# BAR Members = BAAL Priests

# Terms of the Contract

- I see people argue the terms of the contract all the time
- If you argue the terms of the contract, you give them the contract

# Terms of the Contract - Generally

- Somebody comes up to you and says you owe them \$50.00
- If you say “I paid you \$50 last month”, you admit the contract
- The proper answer is “where is the contract?”
- That is EXACTLY what the IRS does every day and people just send them more money

# Terms of the Contract – Traffic Court

- They say you were speeding
- If you say that you were going the speed limit - you gave them the contract
- You should say; where is your evidence that I am required to follow your speed limits?
- If you argue the terms of the contract and also say that they have no jurisdiction, the judge will see that, and will see that you do not know what you are doing (incompetent), and will then represent you, and rule against you

# Terms of the Contract – Revenue Agencies

- They send you a “Request to File” letter
- If you send them a letter saying that your income was below the required limit – you gave them the contract
- If you argue anything in their statutes, codes, rules, or regulations, you give them the contract
- You should respond with a Registered letter listing the numerous reasons why you are NOT required to file
- If you respond with a letter arguing the terms of the contract, and also saying why they have no jurisdiction, they will see that and then represent you (incompetent), and continue with their solicitations

# Terms of the Contract – Revenue Agencies

- **"Persons who are not taxpayers are not within the system and can obtain no benefit by following the procedures prescribed for taxpayers, such as the filing of claims for refunds."** Economy Plumbing and Heating v. U.S., 470 F.2d 585 (Ct. Cl. 1972)
- **"The revenue laws are a code or a system in regulation of tax assessment and collection. They relate to taxpayers, and not to non-taxpayers. The latter are without their scope. No procedures are prescribed for non-taxpayers, and no attempt is made to annul any of their rights and remedies in due course of law. With them Congress does not assume to deal, and they are neither the subject nor the object of the revenue laws."** Long v. Rasmussen, 281 F. 236, at 238

# Terms of the Contract – a Union

- The Union Agreement said you could seek a remedy at common law and through other remedies
- They filed a grievance
- Over a year later they filed a lawsuit and mentioned the grievance and the union contract
- The court dismissed the case because of lack of jurisdiction
- It is a fundamental rule in any court that before you can file a lawsuit, you have to exhaust your administrative remedies first
- The ONLY argument in this case would be that because the defendants were operating outside the company requirements, that they were in their private capacity

# Terms of the Contract – Letter (solicitation)

- They say your grass is too long and if you do not get it cut, they will fine you \$200.00 under a city ordinance
- You say that you are out of town and will cut it when you get back in 2 weeks – you gave them the contract
- You should reject their offer of contract – pursuant to their Regulation Z truth in lending

# Terms of a Contract – a lawsuit

- Somebody files a lawsuit against you under some statute
- You argue anything – you gave them the contract – (create a controversy)
- You should reject their offer of contract – pursuant to their Regulation Z truth in lending



# Notice for the Record

**Date Received: Ninth day of April, in the year, Two Thousand and Sixteen.**

**I, by Declaration am a man and a declared living American Sovereign standing with Treaty Law of God do accept your offer for value and for the following reasons I am returning your offer, rejected, for discharge and closure;**

- Should be returned within 72 hours pursuant to their Regulation Z truth in lending
- Should be in red ink and signed in red ink
- Should be at a 45 degree angle across (over the top of) their offer of contract
- Should be served by Registered Mail

3. If your citation is for expired drivers license, expired inspection sticker or expired registration sticker, you got it renewed within 20 days of date of violation **AND PAID COUNTY PENALTIES FOR EXPIRED REGISTRATION, a \$20.00 DISMISSAL FEE AND COPY OF THE PROOF OF RENEWAL IS REQUIRED BEFORE IT CAN BE COMPLETED.** If not renewed within 20 days of date of violation, you must pay the full amount of your citation.
