Birth Registration

- **“Every child shall be registered immediately after birth and shall have a name.”** Article 24, Clause 2, International Covenant on Civil and Political Rights

Birth = Status = Roman Law

- “Every child shall have, without any discrimination as to race, colour, sex, language, religion, national or social origin, property or birth, the right to such measures of protection as are required by his status as a minor, on the part of his family, society and the State.” Article 24, Clause 2, International Covenant on Civil and Political Rights

- **“Each State Party to the present Covenant undertakes to respect and to ensure to all individuals within its territory and subject to its jurisdiction the rights recognized in the present Covenant, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.”** Article 2, Clause 1, International Covenant on Civil and Political Rights [emphasis added]

Birth = Status = Roman Law

- **“All persons are equal before the law and are entitled without any discrimination to the equal protection of the law. In this respect, the law shall prohibit any discrimination and guarantee to all persons equal and effective protection against discrimination on any ground such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.”** Article 26 International Covenant on Civil and Political Rights [emphasis added]

Civil Law = Roman Law

- **“"Civil Law," "Roman Law," and "Roman Civil Law" are convertible phrases, meaning the same system of jurisprudence. That rule of action which every particular nation, commonwealth, or city has established peculiarly for itself; more properly called "municipal" law, to distinguish it from the "law of nature," and from international law. See Bowyer, Mod. Civil Law, 19; Sevier v. Riley, 189 Cal. 170, 244 P. 323, 325” Black's Law Dictionary, Rev. 4th Edition [emphasis added]**

Person = Roman Law

- “§ 1. Classification of Persons. The Roman law distinguished three kinds of personal status, or degree? of legal capacity, and classified human beings with respect thereto as follows:...
- § 3. Loss of Freedom (Capitis Deminutio Maxima). A Roman citizen could not legally be sold into slavery, but he might become a slave by condemnation for crime or by being captured by an enemy.” Law of Persons by Joseph R. Long, published 1912 [emphasis added]

- **“(a) When used in this title, where not otherwise distinctly expressed or manifestly incompatible with the intent thereof—**

Color of Law

“the words “person” and “whoever” include corporations, companies, associations, firms, partnerships, societies, and joint stock companies, as well as individuals;”

What happened?

- **“Chap. 854. – An Act to establish a code of law for the District of Columbia.”** which was Approved on March 3, 1901, by the Fifty-Sixth Congress, Session II, at 31 Stat. 1189, and at 2, where it says;
- **“And be it further enacted, That in the interpretation and construction of said code the following rules shall be observed namely:...**
- **“Third. The word “person” shall be held to apply to partnerships and corporations, ...”, [emphasis added]**

Cestui Que use = Roman Cult

- “Yet still it was found difficult to set bounds to ecclesiastical ingenuity; for when they were driven out of all their former holds, they devised a new method of conveyance, by which the lands were granted, not to themselves directly, but to nominal feoffees *to the use* of the religious houses; thus distinguishing between the *possession* and the *use*, and receiving the actual profits, while the seisin of the lands remained in the nominal feoffee, who was held by the courts of equity (then under the direction of the clergy) to be bound in conscience to account to his *cestui que use* for the rents and emoluments of the estate: and it is to these inventions that our practitioners are indebted for the introduction of uses and trusts, the foundation of modern conveyancing.” Tomlins Law Dictionary 1835 edition, Volume 2 under the definition of Mortmain

- ❖ **"Taxpayers are not State Citizens."** Belmont v. Town of Gulfport, 122 So. 10.
- ❖ **"State citizens are the only ones living under free government, whose rights are incapable of impairment by legislation or judicial decision."** Twining v. New Jersey, 211 U.S. 97, 1908
- ❖ **"State Citizenship is a vested substantial property right, and the State has no power to divest or impair these rights."** Favot v. Kingsbury, (1929) 98 Cal. App. 284, 276 P. 1083

State Citizens

- ❖ **"The state citizen is immune from any and all government attacks and procedure, absent contract." see, Dred Scott vs. Sanford, 60 U.S. (19 How.) 393 or as the Supreme Court has stated clearly, "...every man is independent of all laws, except those prescribed by nature. He is not bound by any institutions formed by his fellowmen without his consent."** CRUDEN vs. NEALE, 2 N.C. 338 2 S.E. 70, [emphasis added]

State Citizens

- **“The rights of the individuals are restricted only to the extent that they have been voluntarily surrendered by the citizenship to the agencies of government.”** City of Dallas v Mitchell, 245 S.W. 944
- **"The people or sovereign are not bound by general word in statutes, restrictive of prerogative right, title or interest, unless expressly named. Acts of limitation do not bind the King or the people. The people have been ceded all the rights of the King, the former sovereign,.."** People v Herkimer, 4 Cowen (NY) 345, 348 (1825)

State Citizens

- **"...at the revolution the Sovereignty devolved on the people; and they are truly the sovereigns of the country... the citizens of America are equal as fellow citizens, and as joint tenants in the sovereignty." Chisholm v Georgia, 2 Dall. 440, at pg 471**

- **"It will be admitted on all hands that with the exception of the powers granted to the states and the federal government, through the Constitutions, the people of the several states are unconditionally sovereign within their respective states." - **"A Sovereign is exempt from suit, not because of any formal conception or obsolete theory, but on the logical and practical ground that there can be no legal Right as against the authority that makes the law on which the Right depends." 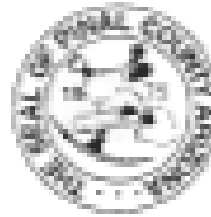

DIET: Regular. Eat plenty of fresh fruits, vegetables, and bran cereals to avoid constipation. If breast-feeding or you had a Cesarean section, then avoid foods that are highly spiced and cause gas.

BREAST CARE: If not breast-feeding, wear a tight fitting bra for the next 3 weeks. **DO NOT** pump your breasts or nurse the baby, this only **makes more milk**. Ice packs for 20 minutes every hour to help when breasts are full. If you are breast-feeding, air dry your nipples for five minutes after nursing and squeeze out a small amount of milk and apply to nipple. Wear nursing pads that are not plastic lined. When your milk comes in you may apply warm compresses to breast to help relieve the discomfort and take Tylenol as necessary if ordered by your physician.

EPISIOTOMY CARE: Your episiotomy takes three weeks to heal inside and out. You will need to continue to use your peri bottle filled with warm water and Acudyne (if ordered by your physician) after each change of your kotex or use of the bathroom. Use the Epifoam three times per day. Sitz baths three to four times per day with Acudyne or Epsom salt for the next one to two weeks, or as directed by your physician.

ACTIVITY: No heavy lifting, except for the baby, no housework, or driving a car, for the next 1 - 2 weeks, for vaginal births, and 2 - 3 weeks for Cesarean births. ~~You have copies of exercises that you may perform in your discharge packets.~~

EDEMA OR SWELLING: It is not unusual to have swelling in your hands and your feet for the next 3 - 6 weeks after the baby is born. You will need to call your physician if the swelling becomes so bad that you are unable to walk or continue with normal daily activities.

SEX: Your physician prefers that you and your partner do not have relations (sex) for the next 4 - 6 weeks, or until your bleeding stops. If so, please use rubbers (condoms) and contraceptive foam to protect yourself against any infections and or pregnancy. Also **do not** use any tampons or douche till after your six week check-up. Also no swimming for 4 - 6 weeks or until your physician says otherwise.

WHEN TO CALL THE PHYSICIAN: Call your doctor if: You have a fever of 100.6 or above, you are passing large blood clots, you are bleeding heavily (soaking through the whole kotex in an hour or less), or if you have a bad odor to your bleeding. ~~If you had a Cesarean section or tubal ligation, call if you have any bleeding or drainage from your incision.~~

MEDICATION: Continue to take your prenatal vitamins and iron for the next 3 months. Motrin 600mg one tablet every six hours if needed for cramps or lesser pain. Tylenol #3, Percocet, or Percodan one or two every 3 - 4 hours for severe pain if ordered by your physician.
