Declaration – Affidavit

- ▣ **“Indeed, no more than (affidavits) are necessary to make the Prima facie case.”**
United States V. Kis, 658 F. 2nd, 526, 536 (7th Cir. 1981); Cert Denied, 50 U.S.L.W. 2169; S. Ct March 22, 1982.
- ▣ **Affidavits are commercial**
 - **Notarized**
- ▣ **Declarations are common law**
 - **Witnesses (2-3 minimum)**
 - **Can be Notarized**

Affidavits & Declarations

- ▣ **Considered “evidence” if done properly**
- ▣ **Make statements of fact**
- ▣ **Avoid opinion**
- ▣ **Avoid conclusions**
- ▣ **Support every statement**
- ▣ **Always keep copies of everything, and copies of proof of service**

6 Steps ~ 90 days to Lawsuit

- ▣ Step 1 - Affidavit of Complaint – 30 days to respond
- ▣ Step 2 – Affidavit of Complaint Second Notice – 30 days to respond
- ▣ Step 3 – Affidavit of Default – 10 days to respond
- ▣ Step 4 – Affidavit of Acceptance – 10 days to respond
- ▣ Step 5 - Affidavit of Truth
- ▣ Step 6 – File Lawsuit

6 Steps

- ▣ The difference between the 5 Affidavit Steps is 1 paragraph
- ▣ If you add additional people, the difference between the basic Affidavit and the Affidavit for additional parties is 1 paragraph
