# Preliminary

- Not all officials at the border are PIGs (but I haven't run into any who are NOT)
- PIG is an acronym = Persons In Government who intends to perjure their oath
- The PIGs in the Parliament and the Legislatures have listed border guards as a "Peace Officer" to give them plausible deniability.
- This procedure takes away their plausible deniability

# We will Cover

- 99.999% of the time, crossing a border has absolutely nothing to do with keeping the peace
- All border guards operate in their official capacity as a Peace Officer, or in their private capacity to collect Revenue (LEOs)
- Many LEOs are low intelligence thugs
- Some ideas about how to deal with LEOs at a border

- Every situation is different and there is no guaranteed way to do anything

# Low Intelligence LEOs

- They screen out intelligent people in the hiring process for their Law Enforcement Officers (LEOs)
- Jordan vs City of New London, US Court of Appeals for the Second Circuit Case Number 99-9188
- Robert Jordan had a masters degree and scored too high on their test – too intelligent!
- I know several people who were NOT hired for these kind of positions because they scored too high on their test.

# LEOs = Order Followers

- ❖ Anyone who is wearing a military uniform is an agent of the Vatican
- ❖ **“The wearing of clerical dress or of a religious habit on the part of lay folk, ....., is liable to the same penalty on the part of the State as the misuse of military uniform.”** Article 10, Concordat of 1933
- ❖ Almost all (so-called) governments are bankrupt and owned and operated by the Vatican
- ❖ At common law a sheriff would have a star only.
- ❖ At common law there is no uniform



# LEOs = Order Followers

- WWII War Crimes Tribunals
  - All of the NAZIs claimed that they were just following orders - Satanists
  - They either suffered death by hanging, or spent the rest of their life in jail
  - Some of them are still hunted to this day
- Vietnam War - Mai Lai massacre
  - Convicted of murder
- Today Order Followers are everywhere

# Peace Officers

- All Canada Border Services Agency officers have the words “Peace Officer” on their military uniforms, but if there is no breach of the peace, then they are not operating in their official capacity, but they are operating completely in their private capacity.
- I have NEVER in my life breached the peace
- These Canada Border PIGs breach the peace dozens of times every day.

# Border Stop by LEOs

- ❖ It is a good idea to put both hands on the top of the steering wheel
- ❖ Be polite, but Do NOT give them anything, unless you absolutely have to and even then under protest
- ❖ My daughter was on a grand jury for about a year and she told me that it is amazing how many times the police would ask somebody; “Is that marijuana” and they would say; “yes”
- ❖ Everything they are looking for is hearsay evidence and they need you to give the evidence, or it is NOT admissible in their kangaroo court
- ❖ If you can, record the event

# Hearsay Evidence = No Witnesses

- Date of birth is hearsay – do you remember the day you were given birth,...I don't
- Your name is hearsay,...how do you know what your name is,...somebody told you,...hearsay
- Your picture is hearsay – it is an image – all images are hearsay
- Your Drivers License is hearsay – how does anybody know that you didn't make that up at home
- A computer entry is hearsay – how does anybody know that hackers didn't hack their computer system

# Hearsay Evidence = Fraud = Satanism

- Vehicle Registration is hearsay
- Vehicle Insurance is hearsay
- DO NOT GIVE EVIDENCE AGAINST YOURSELF!!!!!!
- If you do not give evidence against yourself, THEY HAVE NOTHING!
- They have no witnesses!

# Border Stop by LEOs

- ❖ Tell them you have no problem providing whatever they want, but you have a couple of questions first
- ❖ Ask them if there was a breach of the peace – they should answer “NO”
- ❖ Ask them if they have a court order – they should say “NO”

# Border Stop by LEOs

- **“Since there was no breach of the peace and you do not have a court order, then just so I understand what is going on here,...you are not operating in your official capacity as a peace officer, but you are operating in your private capacity to collect revenue, is that correct?”**
- Do you have any evidence that I am carrying passengers or property for hire – he should answer “NO”
- Do you have any evidence that I am one of your duty paying units? - No

# Border Stop by LEOs

- Since you are operating in your private capacity as a revenue officer, and you have that uniform on, then you are personating a peace officer (a felony in some states)
- Tell that everything they are looking for is hearsay evidence and inadmissible as evidence in a court of law
- Get your boss out here, maybe I should be placing you under arrest for personating a Peace Officer



# Plausible Deniability

- **“Where a person is required or authorized by law to execute a process or to carry out a sentence, that person or any person who assists him is, if that person acts in good faith, justified in executing the process or in carrying out the sentence notwithstanding that the process or sentence is defective or that it was issued or imposed without jurisdiction or in excess of jurisdiction.” Section 25 (2) Criminal Code of Canada**

# Personation = PIGs

- **“Personating peace officer**
- **(1) Everyone commits an offence who**
- **(a) falsely represents himself to be a peace officer or a public officer; or**
- **(b) not being a peace officer or public officer, uses a badge or article of uniform or equipment in a manner that is likely to cause persons to believe that he is a peace officer or a public officer, as the case may be.”** Section 130, Criminal Code of Canada

# Border Stop by PIGs

- Because of the communists in Parliament, everybody is required to have “papers”
- Get alternative Common Law Identification card;
- National Standards Enforcement Agency

- There are common law identification cards available in Canada

# No such thing as a drivers license

- *This court has held that there is no such license known to Texas Law as a “driver’s license.”* Frank John Callas v. State, 167 Tex. Crim. 375; 320 S.W. 2d 360
- *We have held that there is no such license as a driver’s license known to our law.* Claude D. Campbell v. State, 160 Tex. Crim. 627; 274 S.W.2d 401

# No such thing as a Drivers License

- *An information charging the driving of a motor vehicle upon a public highway without a driver's license charges no offense, as there is no such license as a driver's license known to the law.*  
Keith Brooks v. State 158 Tex. Crim. 546; 258 S.W.2d 317
- *There being no such license as a "driver's" license known to the law, it follows that the information, in charging the driving of a motor vehicle upon a highway without such a license, charges no offense.* W. Lee Hassell v. The State, 149 Tex. Crim. 333; 194 S.W.2d 400

# No such thing as a Drivers License

- The reason it is NOT Texas law is because it is United States fictitious color of law
- It applies to their US citizen slave corporations
- They always ask for “your drivers license, registration, insurance”

# Border Stop by PIGs

- Am I under arrest?
- You are being detained
- The courts have ruled that if I am NOT free to go, then I am arrested
- Am I free to go?
- I choose to remain silent and I want my lawyer.
- Go into questions about the Peace Officer previously mentioned

# LEOs = Law Enforcement Officers = PIGs

- **If you are NOT free to go, then you are arrested**
- **“Any restraint, however slight, upon another’s liberty to come and go as one pleases, constitutes an “arrest.”**

Swetnam v. W.F. Woolworth Co., 318 P.2d 364, 366, 83 Ariz. 189.



# False Imprisonment

- **“An illegal arrest is an assault and battery. The person so attempted to be restrained of his liberty has the same right to use force in defending himself as he would in repelling any other assault and battery.”** State v. Robinson, 145 ME. 77, 72 ATL. 260.

# Assault

- **“...the reason for the initial detention, speeding & running a red light are not a breach of the peace.” Perkins v Texas, 812 S.W. 2d 326**

# Canada Border PIGs

- I know people who drive to the border and park their car (or take a bus) and then they walk across, and little if anything is said by the LEOs
- I know people who have gone to foreign countries, like Russia and they send a fax to the local embassy that says **“I am travelling to your country and will arrive on this date and leave on this date”**, and then they say; **“Please send me a letter acknowledging this”** and they will fax back a letter, or snail mail a letter. When they get to the border they present the letter and the guard does not even ask for a Passport

# Letter Text

- I am travelling to Moscow, Russia on 25 December, 2016 and expect to be travelling back on 5 January, 2017
- Please send me a letter acknowledging this.

# Canada Border PIGs

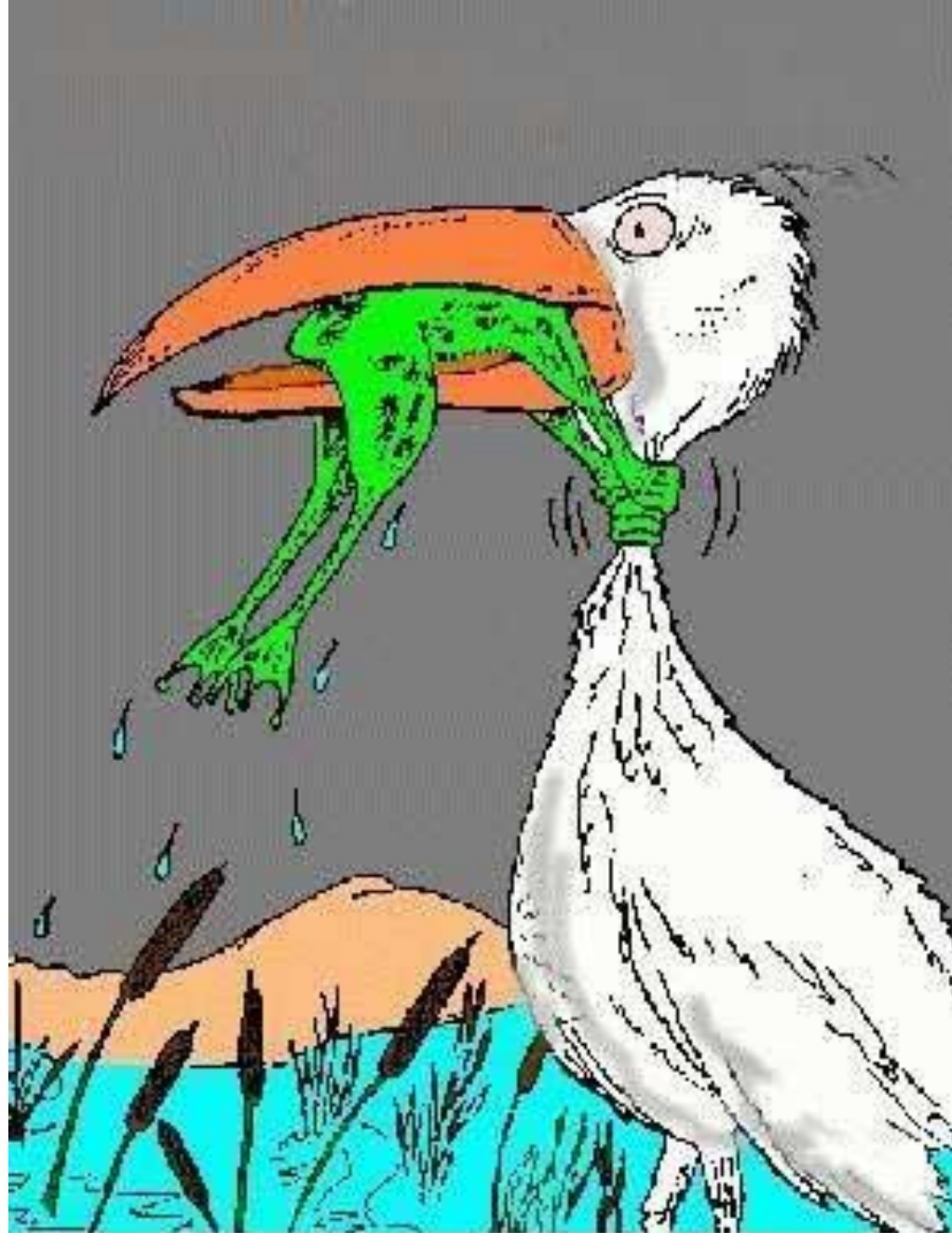
- Do NOT declare anything!
- Do NOT sign anything!
- Do NOT give them a Passport, or a drivers license
- If you absolutely have to, give them the Certificate of Live Birth, and a common law identification card
- I told the PIGs about the fact that if I am not free to go, then I am arrested, and they said you are free to go, but your vehicle has to stay here.
- So you want to buy my private conveyance?
- That is when you sue the PIGs
