United States Post Office

- ❖ **Established 26 July 1775**
- ❖ **Has never been bankrupt**
- ❖ **Articles of Confederation passed by Congress 1777, and ratified 1781**
- ❖ **Constitution ratified 1787**
- ❖ **Handles the post**

United States Postal Service

- ❖ **Established 12 August, 1970**
- ❖ **ZIP CODEs started by Proclamation 3746, September 20, 1966 by President Johnson**
- ❖ **All employees are US citizens**
- ❖ **For the District of Columbia and the Territories**
- ❖ **Handles the mail**

United States Postal Service

- **“AN ACT to improve and modernize the postal service, to reorganize the Post Office Department, and for other purposes.**
- **Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled. That this Act may be cited as the "Postal Reorganization Act"”** August 12, 1970, 84 Stat. 719
- **“§ 201 United States Postal Service. There is established, as an independent establishment of the executive branch of the Government of the United States, the United States Postal Service.”**
84 Stat 720

2 States in every State

- There is a lawful de jure State
- There is a federal territory (municipal corporation)
- **“There has been created a fictional federal State (of) xxxxxx within a state. See Howard v. Sinking Fund of Louisville, 344 U.S. 624, 73 S.Ct. 465, 476, 97 L.Ed. 617 (1953)”**; Schwarts v. O'Hara TP School District, 100 A 2d. 621, 625, 375, Pa. 440,
- State Citizens are in the State
- US citizens are in the territory

State Statutes are actually Federal Statutes

- **“INTERNATIONAL LAW RULE: Adopted for areas under Federal legislative jurisdiction”**
“Federalizes State civil law, including common law.--The rule serves to federalize not only the statutory but the common law of a State. Kniffen v. Hercules Powder Co., 164 Kan. 196, 188 P.2d 980 (1948); Kaufman v. Hopper, 220 N.Y. 184. 115 N.E. 470 (1917), see also 151 App. Div. 28, 135 N.Y.Supp. 363 (1912), aff'd., 163 App. Div. 863, 146 N. Y. Supp. 1096 (1914); Norfolk & P.B.L.R. v. Parker,...” Jurisdiction over Federal Areas Within the States – Report of the Interdepartmental Committee for the Study of Jurisdiction over Federal Areas Within the States, Part II, A Text of the Law of Legislative Jurisdiction Submitted to the Attorney General and Transmitted to the President June 1957, page 158

State Statutes are actually Federal Statutes

- **STATE AND FEDERAL VENUE DISCUSSED: The civil laws effective in an area of exclusive Federal jurisdiction are Federal law, notwithstanding their derivation from State laws, and a cause arising under such laws may be brought in or removed to a Federal district court under sections 24 or 28 of the former Judicial Code (now sections 1331 and 1441 of title 28, United States Code), giving jurisdiction to such courts of civil actions arising under the "*** * * laws * * *** of the United States" where the matter in controversy exceeds the sum or value of \$3,000, exclusive of interest and costs."**
- Jurisdiction over Federal Areas Within the States – Report of the Interdepartmental Committee for the Study of Jurisdiction over Federal Areas Within the States, Part II, A Text of the Law of Legislative Jurisdiction Submitted to the Attorney General and Transmitted to the President June 1957, page 165 [emphasis added]

It is all for US citizens

- a US citizen is NOT entitled to an Article 3 Court, but instead gets an Article 1 Court with a plenary (military dictatorship) jurisdiction and Art. 1, Section 8, Clause 17 Constitution for the United States of America as defined and reinstated in *National Mutual Insurance Company of the District of Columbia v. Tidewater Transfer Company*, 337 U.S. 582, 93 L.Ed. 1556 (1948): which further states that **citizens of the District of Columbia are not embraced by the judicial power under Article III** of the Constitution for the United States of America, the same statement is held in *Hepburn v. Dundas v. Elizey*, 2 Cranch (U.S.) 445, 2 L.Ed. 332.; In 1804, the Supreme Court, through Chief Justice Marshall, held that a citizen of the District of Columbia was not a citizen of a state;

It is all for US citizens

- **"We therefore decline to overrule the opinion of Chief Justice Marshall: We hold that the District of Columbia is not a state within Article 3 of the Constitution. In other words cases between citizens of the District and those of the states were not included of the catalogue of controversies over which the Congress could give jurisdiction to the federal courts by virtue of Article 3. In other words Congress has exclusive legislative jurisdiction over citizens of Washington District of Columbia and through their plenary power nationally covers those citizens even when in one of the several states as though the district expands for the purpose of regulating its citizens wherever they go throughout the states in union" National Mutual Insurance Company of the District of Columbia v. Tidewater Transfer Company, 337 U.S. 582, 93 L.Ed. 1556 (1948)**

It is all for US citizens

- **"If any citizen or resident of the United States does not reside in (and is not found in) any United States Judicial District, such citizen or resident shall be treated as residing in The District of Columbia for purposes of any provisions of this Title to “ (A) jurisdiction of courts, or (B) enforcement of summons.” 26 USC § 7701(39) see also 26 USC § 7408(C)**

Fabricating Evidence

- **"... (E)very taxpayer is a cestui qui trust having sufficient interest in the preventing abuse of the trust to be recognized in the field of this court's prerogative jurisdiction . ." In Re Bolens (1912), 135 N.W. 164.**
- **"A "*citizen of the United States*" is a civilly dead entity operating as a co-trustee and co-beneficiary of the *PCT (Public Charitable Trust)*, the constructive, *cestui que trust* of US Inc. under the 14th Amendment, which upholds the debt of the USA and US Inc." Congressional Record, June 13 1967, pp. 15641-15646**

Citizenship Classes

❖ **"...it might be correctly said that there is no such thing as a citizen of the United States. A citizen of any one of the States of the Union, is held to be, and called a citizen of the United States, although technically and abstractly there is no such thing."** Ex Parte Frank Knowles, 5 Cal. Rep. 300,

State Citizens

- **"State citizens are the only ones living under free government, whose rights are incapable of impairment by legislation or judicial decision."** *Twining v. New Jersey*, 211 U.S. 97, 1908
- **"State Citizenship is a vested substantial property right, and the State has no power to divest or impair these rights."** *Favot v. Kingsbury*, (1929) 98 Cal. App. 284, 276 P. 1083,
- **"The State cannot diminish rights of the people."** *Hertado v. California*, 110 U.S. 516

Federal Jurisdiction

- **Texas (and every other state is foreign to the United States (District of Columbia) if you are a State Citizen**
- **If you are a US citizen, then you are in the District of Columbia everywhere, and Texas is a territory for US citizens**

Federal Jurisdiction

- **"The exclusive jurisdiction which the United States have in forts and dock-yards ceded to them, is derived from the express assent of the States by whom the cessions are made. It could be derived in no other manner; because without it, the authority of the State would be supreme and exclusive therein," U.S. v. Bevans, 16 U.S. 336, 3 Wheat, at 350, 351 (1818).
[emphasis added]**

Federal Jurisdiction

- **“It is a well established principle of law that all federal regulation applies only within the territorial jurisdiction of the United States....”**
Foley Brothers, Inc. v. Filardo, 336 U.S. 281 (1949)
- **“There is a canon of legislative construction which teaches Congress that, unless a contrary intent appears legislation is meant to apply only within the territorial jurisdiction of the United States [the District of Columbia].”** U.S. v. Spelar, 338 U.S. 217 at 222

Federal Jurisdiction

- **“In the sense of public international law, the several states of the Union are neither foreign to the United States nor are they foreign to each other, but such is not the case in the field of private international law.”**
Robinson v. Norato, 71 RI 256, 43 A2d 467, 162 ALR 362. [Emphasis added]
- **"The United States Government is a foreign corporation with respect to a State of the Union."** In Re Merriam's Estate, 36 N.E. 505, 141 N.Y. 479, affirmed 16 S.Ct. 1073, 41 L.Ed. 287

Postage - D.C. & Territories

- **“Sec. 22. And be it further enacted, That the rate of postage on all domestic letters transmitted in the mails of the United States, and not exceeding one half ounce in weight, shall be uniform at three cents; and for each half ounce, or fraction thereof of additional weight, there shall be charged an additional rate of three cents, to be in all cases prepaid by postage stamps plainly affixed to such letter”. Chapter 71, Section 22, 12 Stat. 705, Approved March 8, 1863**

Postage – Post Office

- **“Sec. 23 . And be it further enacted, That the rate of postage on all letters not transmitted through the mails of the United States, but delivered through the post-office or its carriers, commonly described as local or drop letters, and not exceeding one half ounce in weight; shall be uniform at two cents, and an additional rate for each half ounce or fraction thereof additional weight, to be in all cases prepaid by postage stamps affixed to the envelope of such letter, but no extra postage or carrier's fee shall hereafter be charged or collected upon letters delivered by carriers, nor upon letters collected by them for mailing or for delivery .”**

Chapter 71, Section 23, 12 Stat. 705, Approved March 8, 1863 [emphasis added]

General Post-Office

- **“Sec. 2. And be it further enacted, That the Postmaster-General, all postmasters, and special agents, and all persons employed in the General Post-Office, or in the care, custody, or conveyance of the mail, hereafter appointed or employed, shall, previous to entering upon the duties assigned to them, or the execution of their trusts, and before they shall be entitled to receive any emoluments therefor, in addition to the oath of office prescribed by the act of July two, eighteen hundred and sixty-two, respectively take and subscribe the following oath or affirmation....” 12 Stat. 71, Chapter 71, Sec. 2, Approved March 8, 1963**

United States Postal Service

- USPS is a Transmitting Utility
- USPS Employees have oaths
- General Post-Office have 2 oaths
- Employees receive emoluments
- **“emolument - Any advantage, profit, or gain received as a result of one's employment or one's holding of office.”** Black’s Law Dictionary 8th Edition, page 1586

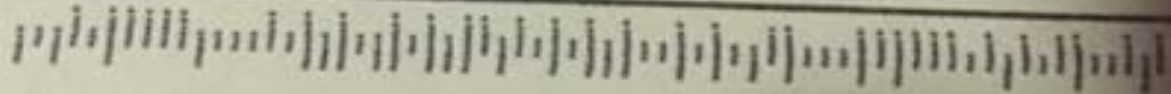

Method 2 - Important Points

- Your signature – I use red ink – your signature is your post mark
- One time I signed a stamp in front of a postal clerk and they told me that I cancelled the stamp.
- Your signature makes you the post master
- Date – I didn't use it – Post Office corrected it.
- Notice how a 2¢ is used on the green card, so you are not taking advantage of any benefit.
- These ones show the use of self adhesive labels, but you can print directly on the envelope or green card

- In addition to the item shown in the pictures, I have sent out dozens of certified letters using this method
- I am planning on doing some Registered in the near future
- I drop them in the mail box
- Some of them start tracking online immediately
- Some of them start tracking at the first major city

Obstruction of the Mail

- **“Whoever knowingly and willfully obstructs or retards the passage of the mail, or any carrier or conveyance carrying the mail, shall be fined under this title or imprisoned not more than six months, or both.” 18 USC § 1701**

Universal Postal Union

Letter Post Manual

- **“Article RL 114 - Prepayment. Methods of denoting prepayment**
- **1 Principle**
- **1.1 As a general rule, items shall be fully prepaid by the sender.**
- **2 Methods of denoting prepayment**
- **2.1 Prepayment shall be denoted by means of any one of the following methods:**
- **2.2 Items may also be provided with an indication that full postage has been prepaid, for example, “Taxe perçue” (“Postage paid”). This indication shall appear in the top right-hand part of the address side and be authenticated by a date-stamp impression of the office of origin.....” Page C.14-C.15**

- **O.H.M.S. = On Her Majesties Service**
- **IMM = International Mail Manual**
- **Made a sheet of self adhesive labels**
- **Takes the article to the Clerk – if the Clerk asks about it, she says; “it is not my job to teach you how to do your job”**
- **Has done Registered Mail**

International Mail Manual

- **742 Stamps Not Affixed**
- **742.1 Marking**
- **Some items of foreign origin do not bear postage stamps, but instead are marked “POSTAGE PAID,” “ON POSTAL SERVICE,” “SERVICE DES POSTES,” “TAXE PERCUE” or “TP,” or “PORT PAYE” or “PP,” followed by postmark. The marking *On Her Majesty’s Service* or *O.H.M.S.* is also sometimes used. Treat this mail as prepaid.**
- **742.2 Parcels Without Postage Stamps**
- **Some foreign post offices do not put postage stamps on parcels. All such parcels received must be regarded as prepaid.**
