Prison agents catch Calif. parolee after 32 years

MONROVIA, Calif. (AP) — California corrections officials have finally caught up with a parolee convicted of murder who had eluded them for more than three decades.

Richard Bradford had been living under the false identity of James Edward Heard and owned several properties in the Pasadena area, including a drug rehabilitation facility, authorities said.

Bradford was sentenced to life for first-degree murder in 1971, was paroled in 1978, and skipped out on his parole supervision in 1980, the Department of Corrections and Rehabilitation said in a statement Wednesday.

Agents arrested Bradford this week, more than 32 years after he had disappeared, the statement said.

A false birth certificate with Heard's name was created in Alameda County in 1977, and a Social Security card was issued to him in 1978, both while he was still in prison, officials said.

By the early 1980s Bradford began using the new name, and the name Richard Bradford disappeared on paper by 1992.

A parole apprehension team began an investigation into his disappearance in 2010 and about a year later learned he might be the same person as Heard. Bradford's prison fingerprints were found to be a match with Heard's from the Department of Motor Vehicles.

Bradford's attorney contacted corrections officials at about the same time saying he knew he was being sought and would like some time to turn himself in, but he never did.

It took investigators two years to find Bradford, who had been keeping a low profile in the Pasadena area, with his businesses controlled by a trust and his credit cards and vehicles in the name of his treatment center.

On Sunday while conducting surveillance, agents saw Bradford and his wife leave their home and followed them to the Home Depot just east of Pasadena in Monrovia, where they arrested Bradford and his wife, who was taken into custody for being a felon in possession of pepper spray. Her name was not released.

A search of the house turned up evidence for both of Bradford's names, the statement said.

Corrections officials did not provide the name of Bradford's attorney, and no other contact information to seek comment from a lawyer or fan.

- Sec. 38.02. FAILURE TO IDENTIFY. (a) A person commits an offense if he intentionally refuses to give his name, residence address, or date of birth to a peace officer who has lawfully arrested the person and requested the information.
- Was he operating as a Peace Officer?
- Was it a lawful arrest?

Peace Officer vs PIG

- Was there a Breach of the Peace?
- Is there a court order?
- Do you have evidence that I am carrying passengers or property for hire?
- If the answer to these 3 questions is NO, then it is a PIG you are dealing with – NOT a Peace Officer
- If the answers to these 3 questions is NO, then it is NOT a lawful arrest (it is an assault)

Government Issued Identification = Hearsay Evidence

- Date of birth = hearsay
- Name = hearsay
- Address = hearsay
- Image = hearsay
- Identification = hearsay
- Everything they want from you is hearsay and they need you to introduce it, or it is inadmissible as evidence
- **Quit introducing evidence against yourself!!**

Government Issued Identification

- Is it yours? - NO
- It belongs to the state
- The State can revoke it – that means it is theirs
- Does it have your name on it? – NO! – It has the name of a cestui que trust on it.

Social Security Number

- **"... (E)very taxpayer is a cestui qui trust having sufficient interest in the preventing abuse of the trust to be recognized in the field of this court's prerogative jurisdiction . . ." In Re Bolens (1912), 135 N.W. 164.**
- **"A "*citizen of the United States*" is a civilly dead entity operating as a co-trustee and co-beneficiary of the *PCT (Public Charitable Trust)*, the constructive, *cestui que trust* of US Inc. under the 14th Amendment, which upholds the debt of the USA and US Inc." Congressional Record, June 13 1967, pp. 15641-15646**

Social Security Number

- ❖ A Social Security Number is a number for a cestui que trust
- ❖ No living soul has a Social Security Number
- ❖ There is no law that says anybody has to get a Social Security Number
- ❖ There are court cases that say that you cannot cancel or revoke a Social Security Number
- ❖ Quit using their Social Security Number
- ❖ If you cannot have it without producing a Social Security Number, then consider doing without it,

Social Security Number

- ❖ If you have a mortgage, then your living location is in a database based on the Social Security Number of the cestui que trust associated with your name
- ❖ If you are in the position of having withholdings taken from your compensation for the IRS thieves, then anyone can find you at your work
- ❖ I filed a lawsuit against FEDEX a few years ago, and when I was effecting service I was communicating with process servers and they told me that if I knew a Social Security Number, they could get a home address for service.

Hearsay Evidence

- Quit using a date of birth
- A Date of birth is hearsay – do you remember the day you were given birth – I do NOT!

How to Disappear

- There are various degrees of being able to disappear
- If these things are done properly, you will become transparent to the government
- They will NOT be able to see you
- You do NOT need to go to some foreign country or open bank accounts in foreign countries
- You can be right here and right in front of them and they will not be able to see the forest for the trees

How to Disappear – Quit Using their Words

- I do NOT have assets but I do have property
- I do NOT have a spouse, but I am joined in the bonds of holy matrimony
- I do NOT have children but I have sons and daughters, or better yet, I have property and show a picture
- I do NOT have income but I do get compensation for my labor
- I do NOT drive, but I do travel

How to Disappear – Quit Using Their Words

- I do NOT have an employer, but I do exercise my right to pursue happiness by getting compensation for my labor
- I do NOT have a government issued identification but I do have a American National Identification Card provided by NSEA.US

How to Disappear

- 1 – Nobody has a Birth Certificate
- 2 - Nobody has a Social Security Number
- 3 – Nobody has a drivers license
- 4 – A date of birth is hearsay and I have no first hand knowledge of that
- 5 – Transfer owned real estate to trusts
- 6 – Transfer vehicles to trusts
- 7 – Set up Utilities in the name of the Trusts
- 8 – Get common law identification cards

How to Disappear

- Make it so they do NOT want to talk to you

- Use bitcoin, cash, gold or silver coin
- Open Bank accounts with no SSN
- Bring forward all of the rights and privileges of the original 1 and patent on your land – see the Do you Own Your Land video

Making Merchandise of you

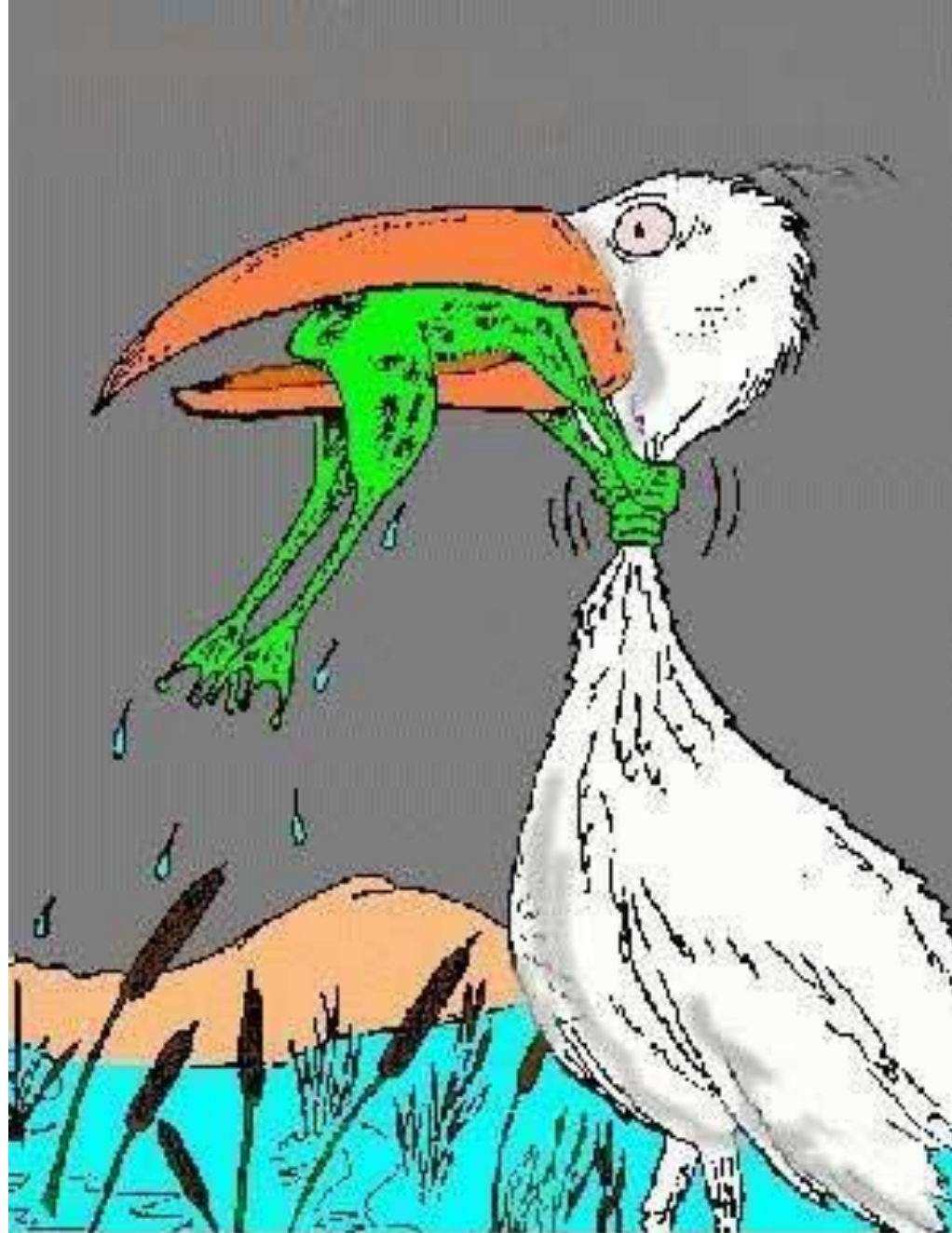
