Order Followers

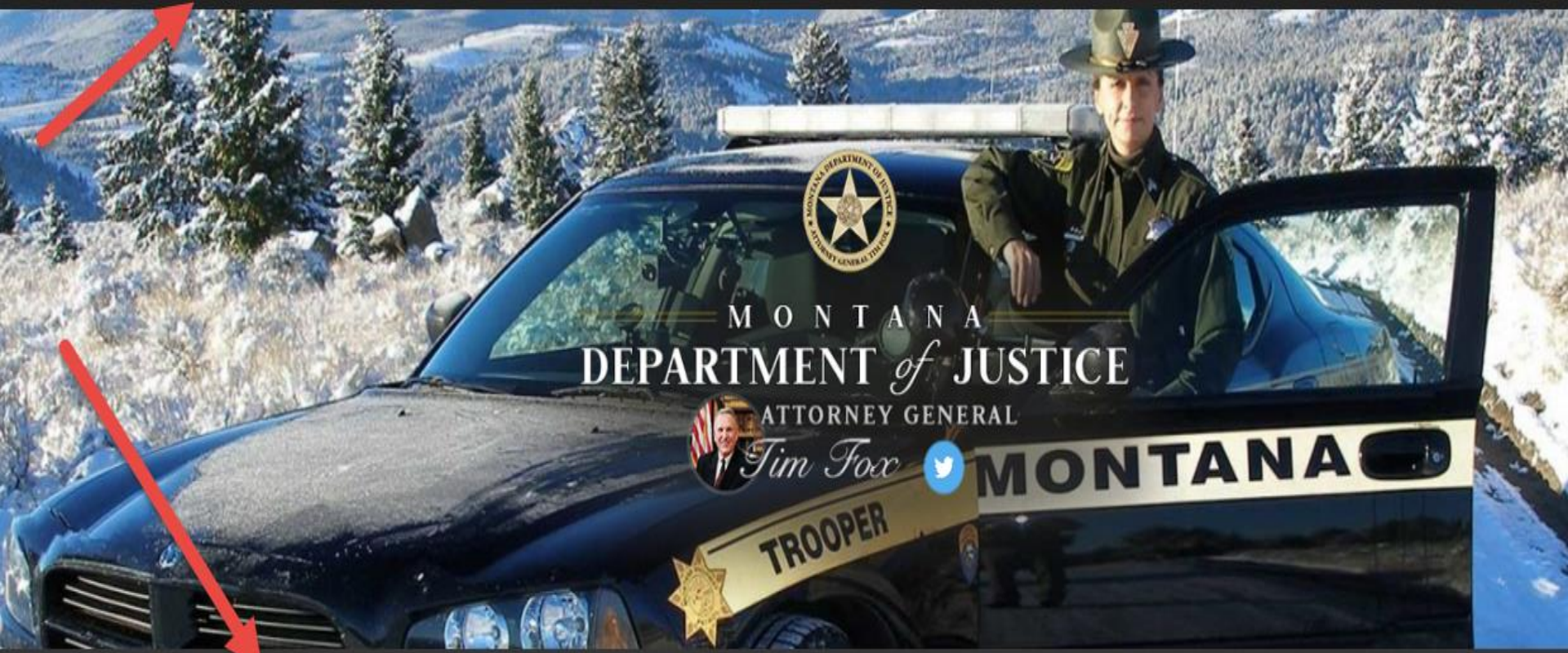
- WWII War Crimes Tribunals

Montana Highway Patrol PIGs

- On 11 September 2016 Walker County, Texas PIGs JACOBSEN and MCKAY assaulted me with an unlawful arrest, and during the assault they commented that I have a “piece of shit truck”
- The reason I have a “piece of shit truck” is because of PIGs like Jacobsen, US Marshalls PIGs and Texas DPS PIGs who put me down as Armed and dangerous because I served a letter on them stating that I had the right to resist their unlawful arrest with lethal force if necessary, and I have not been able to get a compensation for labor contract for 4 years

Montana Highway Patrol PIGs

- Walker County, Texas PIG JACOBSEN followed me for over 5 miles before he stopped me for a “burned out third brake light”
- When I asked JACOBSEN if there was a Breach of the Peace, JACOBSEN refused to answer
- When I asked JACOBSEN if he had a court order JACOBSEN refused to answer
- When I asked JACOBSEN if he had evidence that I was carrying passengers or property for hire, he refused to answer

Commercial

- **"The term "Motor Vehicle" means every description of carriage or other contrivance propelled or drawn by mechanical power and used for commercial purposes on the highways in the transportation of passengers, passengers and property, or property or cargo.**
- **The term "used for commercial purposes" means the carriage of persons or property for any fare, fee, rate, charge or other consideration, or directly or indirectly in connection with any business, or other undertaking intended for profit." 18 USC § 31 [emphasis added]**

Montana Highway Patrol PIGs

- JACOBSEN had me standing in handcuffs on the side of the road for approximately an hour
- JACOBSEN was demanding to know my name, my date of birth, my drivers license, my insurance, and my registration
- I told JACOBSEN that everything he was looking for was hearsay evidence and I had no firsthand knowledge of any of it
- JACOBSEN repeatedly went to his radio to get instructions from his unknown handlers – probably his coward boss
- I told JACOBSEN that he was not operating in his official capacity, but was operating in his private capacity as a revenue officer under the Federal Tax Lien Act of 1966

LEOs use Law Merchant (UCC)

- **"(h) DEFINITION's. "(3) MOTOR VEHICLE.-The term 'motor vehicle' means a self-propelled vehicle which is registered for highway use under the laws of any State or foreign country. "(4) SECURITY.-The term 'security' means any bond, debenture, note, or certificate or other evidence of indebtedness, issued by a corporation or a government or political subdivision thereof, with interest coupons or in registered form, share of stock, voting trust certificate, or any certificate of interest or participation in, certificate of deposit or receipt for, temporary or interim certificate for, or warrant or right to subscribe to or purchase any of the foregoing: negotiable instrument: or money."** Federal Tax Lien Act of 1966 at Public Law 89-719 at 80 Stat.¹⁶

Montana Highway Patrol PIGs

- Operating in private capacity
- **“All oaths must be lawful, allowed by the common law, or some statute; if they are administered by persons in a private capacity, or not duly authorized, they are *coram non judice*, and void; and those administering them are guilty of a high contempt, for doing it without warrant of law, and punishable by fine and imprisonment. 3 *Inst.* 165; 4 *Inst.* 278; 2 *Roll. Abr.* 277.”** Tomlin’s Law Dictionary 1835 Edition, Volume 2
- **“An officer who acts in violation of the Constitution ceases to represent the government”.** Brookfield Const. Co. v. Stewart, 284 F. Supp. 94.

Montana Highway Patrol PIGs

- **“The power to create presumptions is not a means of escape from constitutional restrictions.”** Bailey v Alabama, 219 U.S. 219, 238, et seq., 31 S.Ct. 145; Manley v Georgia, 279 U.S. 1, 5-6, 49 S.Ct. 215,

Montana Highway Patrol PIGs

- **“No one is bound to obey an unconstitutional law and no courts are bound to enforce it.”** 16th American Jurisprudence 2d, Section 177 late 2nd, Section 256
- **“An unconstitutional act is not law; it confers no rights; it imposes no duties; affords no protection; it creates no office; it is in legal contemplation, as inoperative as though it had never been passed.”** Norton vs Shelby County, 118 U.S. 425, p. 442
- **"An unconstitutional law is void, and is as no law. An offence created by it is not a crime."** Ex parte Siebold, 100 U.S. 371, 376 (1880), quoted with approval in Fay v. Noia, 372 U.S. 391, 408 (1963)
- **"it never became a law and was as much a nullity as if it had been the act or declaration of an unauthorized assemblage of individuals."** (Ryan v. Lynch, 68 Ill. 160)

Montana Highway Patrol PIGs

- I told JACOBSEN that he was under arrest for impersonating a public servant and that is a felony under Texas statutes and federal statutes
- I told JACOBSEN that I wanted to see his boss
- JACOBSEN told me that his boss was not coming out there.
- JACOBSEN resisted his arrest
- I was NOT charged with anything, and was NOT read my rights

1. Michael Tooley, Colonel, Chief Administrator, Montana Highway Patrol, I accept your Oath of Office. Please find an Oath of Office acceptance document attached hereto, and incorporated herein by reference in its entirety.
2. Michael Tooley, Colonel, Chief Administrator, Montana Highway Patrol, equality under the Law is paramount and mandatory by Law.
3. Michael Tooley, Colonel, Chief Administrator, Montana Highway Patrol, I did not give you, the authority for making a legal determination for Me.
4. Michael Tooley, Colonel, Chief Administrator, Montana Highway Patrol, et al, if you think or assume that you are representing Me, you are FIRED!

38. You, Michael Tooley, Colonel, Chief Administrator, Montana Highway Patrol, are NOTICED that I have the right to resist unlawful arrest with lethal force if necessary, as found in the Notice and Demand to all Corporate Commercial Agents 022810 which is recorded with the PINAL COUNTY RECORDER at FEE NUMBER 2010-034479, and also;

“These principles apply as well to an officer attempting to make an arrest, who abuses his authority and transcends the bounds thereof by the use of unnecessary force and violence, as they do to a private individual who unlawfully uses such force and violence.” Jones v. State, 26 Tex. App. 1; Beaverts v. State, 4 Tex. App. 1 75; Skidmore v. State, 43 Tex. 93, 903.

“An illegal arrest is an assault and battery. The person so attempted to be restrained of his liberty has the same right to use force in defending himself as

he would in repelling any other assault and battery.” (State v. Robinson, 145 ME. 77, 72 ATL. 260).

“Each person has the right to resist an unlawful arrest. In such a case, the person attempting the arrest stands in the position of a wrongdoer and may be resisted by the use of force, as in self-defense.” State v. Mobley, 240 N.C. 476, 83 S.E. 2d 100.

“One may come to the aid of another being unlawfully arrested, just as he may where one is being assaulted, molested, raped or kidnapped. Thus it is not an offense to liberate one from the unlawful custody of an officer, even though he may have submitted to such custody, without resistance.” (Adams v. State, 121 Ga. 16, 48 S.E. 910).

Story affirmed the right of self-defense by persons held illegally. In his own writings, he had admitted that **“a situation could arise in which the checks-and-balances principle ceased to work and the various branches of government concurred in a gross usurpation.”** There would be no usual remedy by changing the law or passing an amendment to the Constitution, should the oppressed party be a minority. Story concluded, **“If there be any remedy at all ... it is a remedy never provided for by human institutions.”** That was the **“ultimate right of all human beings in extreme cases to resist oppression, and to apply force against ruinous injustice.”** (From Mutiny on the Amistad by Howard Jones, Oxford University Press, 1987, an account of the reading of the decision in the case by Justice Joseph Story of the Supreme Court.

39. You, Michael Tooley, Colonel, Chief Administrator, Montana Highway Patrol, are NOTICED that I have an unlimited right to carry arms, whether concealed or not.

“The carrying of arms in a quiet, peaceable, and orderly manner, concealed on or about the person, is not a breach of the peace. Nor does such an act of itself, lead to a breach of the peace.” Wharton's Criminal and Civil Procedure, 12th Ed., Vol.2: Judy v. Lashley, 5 W. Va. 628, 41 S.E. 197

40. You, Michael Tooley, Colonel, Chief Administrator, Montana Highway Patrol, are NOTICED that in the event that one of your hired thugs attempts to unlawfully arrest Me, and I assert My right to resist that unlawful arrest, with lethal force if necessary, and your hired thug kills Me, your hired thug will be guilty of MURDER, and so will you.

“Perhaps it should be mentioned that as a general rule a person is placed under arrest when he is deprived of his liberty by an officer who intends to arrest him. It is not always necessary for the officer to make a formal declaration of arrest. See: 1 Varon, Searches, Seizures and Immunities, 75 (1961);” Henry v. United States, 361 U.S. 98, 4 L.Ed.2d 134, 80 S.Ct. 168 (1959) and United States v. Boston, 330 F.2d 937 (1964).

“The stopping of an automobile by a highway patrol officer for inspection of a driver’s license, or for any other purpose where it is accomplished by the



"A motorist stopped by a traffic officer for a traffic offense would be considered "arrested" . . . even if the motorist was not specifically informed that he had been arrested." People ex rel. Winkle v. Bannan, 125 N.W.2d 875, 879, 372 Mich. 292.

"Any restraint, however slight, upon another's liberty to come and go as one pleases, constitutes an "arrest." Swetnam v. W.F. Woolworth Co., 318 P.2d 364, 366, 83 Ariz. 189.

- **“When acting to enforce a statute and its subsequent amendments to the present date, the judge of the municipal court is acting as an administrative officer and not in a judicial capacity; courts administering or enforcing statutes do not act judicially, but merely ministerially....but merely act as an extension as an agent for the involved agency -- but only in a “ministerial” and not a “discretionary capacity...”** Thompson v. Smith, 154 S.E. 579, 583; Keller v. P.E., 261 US 428; F.R.C. v. G.E., 281, U.S. 464 [emphasis added]

Adversarial Judicial Proceeding =

Kangaroo court

- **"It is the accepted rule, not only in state courts, but, of the federal courts as well, that when a judge is enforcing administrative law they are described as mere 'extensions of the administrative agency for superior reviewing purposes' as a ministerial clerk for an agency..."**
30 Cal 596; 167 Cal 762
- **"...judges who become involved in enforcement of mere statutes (civil or criminal in nature and otherwise), act as mere "clerks" of the involved agency..."** K.C. Davis, ADMIN. LAW, Ch. 1 (CTP. West's 1965 Ed.)

Adversarial Judicial Proceeding = Kangaroo Court

- A Clerk Masquerading as a Judge is not competent to do anything judicial like issue orders, or warrants
- A Clerk Masquerading as a Judge is operating in his private capacity, and has no immunity
- **"Ministerial officers are incompetent to receive grants of judicial power from the legislature, their acts in attempting to exercise such powers are necessarily nullities"** Burns v. Sup., Ct., SF, 140 Cal. 1

Kangaroo Courts are Everywhere!

- **“Kangaroo court. Term descriptive of a sham legal proceeding in which a person's rights are totally disregarded and in which the result is a foregone conclusion because of the bias of the court or other tribunal.” Black’s Law Dictionary, 6th Edition, page 868**

Adversarial Proceeding

- They assault you, kidnap you, and falsely imprison you
- Then they drag you into their kangaroo court
- They bought and paid for Clerk masquerading as a Judge
- Do you think that whore is interested in protecting your rights

Warrant for Arrest????

- **“CAPIAS. A writ or process formerly of two sorts; one whereof in the court of C. P. is called *capias ad respondendum*, before judgment, where an original is sued out, etc. to take the defendant⁴² and make him answer the plaintiff: and the other a writ of execution, after judgment, being of divers kinds, as *capias ad satisfaciendum*, *capitu ultiagatum*, &c.” Tomlin’s Law Dictionary 1835 Edition [emphasis added]**

Warrant for Arrest????

- **“CAPIAS AD SATISFACIENDUM (shortly termed a CA. SA.) A judicial writ of execution which issues out on the record of a Judgment, where there is a recovery in the courts at Westminster, of debt, damages, &c. And by this writ the sheriff is commanded to take the body of the defendant in execution, and him safely to keep, so that he have his body in court at the return of the writ, to satisfy the plaintiff his debt and damages. *Vide 1 Litt Abr. 249.*”**
Tomlin’s Law Dictionary 1835 Edition
- **“A capias is NOT a “Warrant of Arrest,”....”** Knox v State, 586 S.W. 2d 504, 506 (Tex.Crim.App. 1979).

Capias

- **“In this chapter: (1) "Capias" means a writ that is: (A) issued by a court having jurisdiction of a case after judgment and sentence; and (B) directed "To any peace officer of the State of Texas" and commanding the officer to arrest a person convicted of an offense and bring the arrested person before that court immediately or on a day or at a term stated in the writ.**
- **(2) "Capias pro fine" means a writ that is:**
- **(A) issued by a court having jurisdiction of a case after judgment and sentence for unpaid fines and costs; and**
- **(B) directed "To any peace officer of the State of Texas" and commanding the officer to arrest a person convicted of an offense and bring the arrested person before that court immediately.” Texas Code of Criminal Procedure Article 43.015**

Montana Highway Patrol PIGs

The 2nd U.S. Circuit Court of Appeals in New York upheld a lower court's decision that the city did not discriminate against Robert Jordan because

Montana Highway Patrol PIGs

Montana Highway Patrol PIGs

- **“If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; ...They shall be fined under this title or imprisoned not more than ten years, or both; ...”**
18 USC § 241 Conspiracy to Violate Rights under Color of Law [emphasis added]

- **"It is impossible to prove jurisdiction exists absent a substantial nexus with the state, such as voluntary subscription to license. 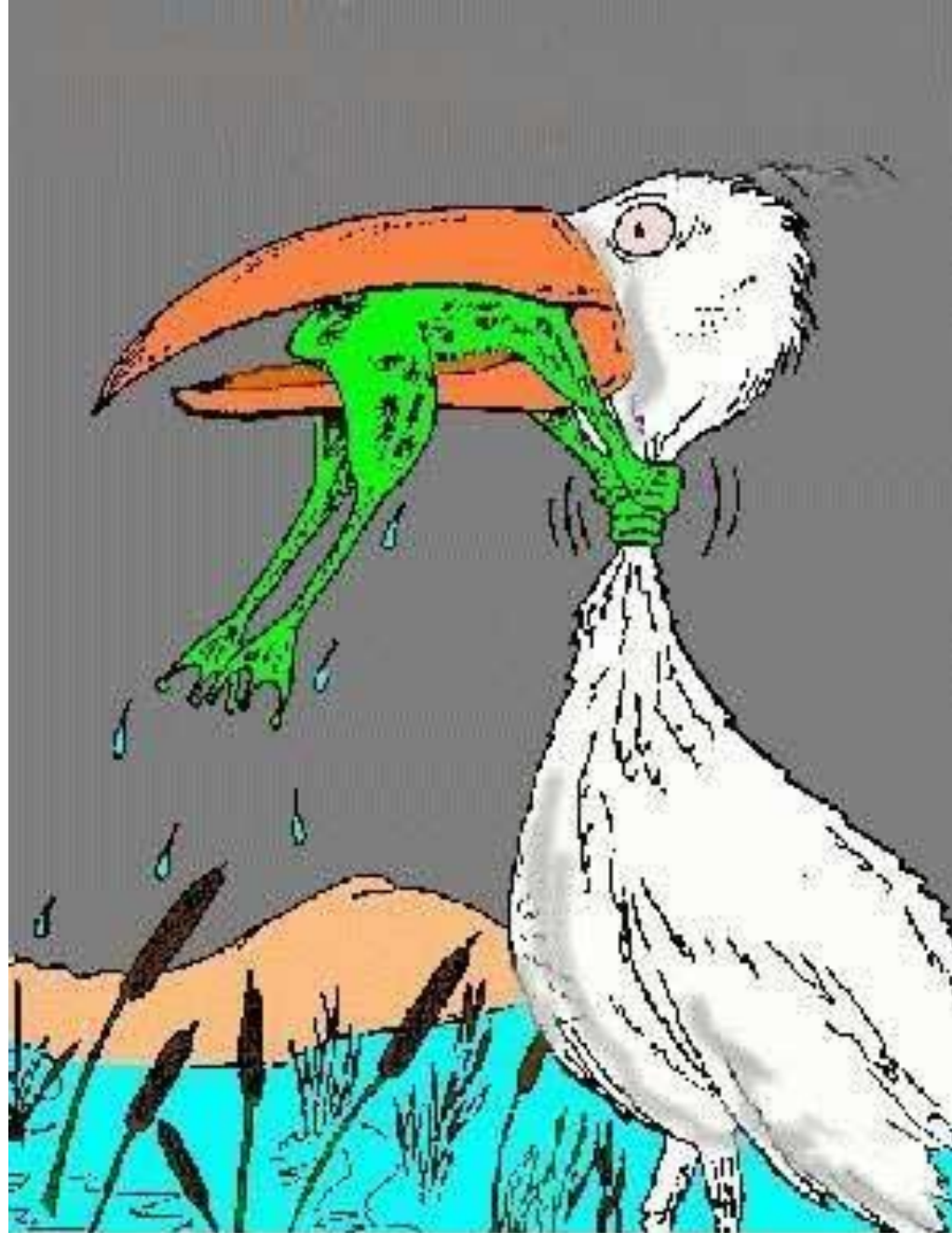
Judgment Day is Coming!
