Martial Law = Satanism

Martial Law = Satanism

- **“...statutes have been passed extending the courts of admiralty and vice-admiralty far beyond their ancient limits for depriving us the accustomed and inestimable privilege of trial by jury, in cases affecting both life and property..... to supersede the course of common law and instead thereof to publish and order the use and exercise of the law martial.... and for altering fundamentally the form of government established by charter. We saw the misery to which such despotism would reduce us.” Causes and Necessity of Taking Up Arms (1775)**

Martial Law Equity = Satanism

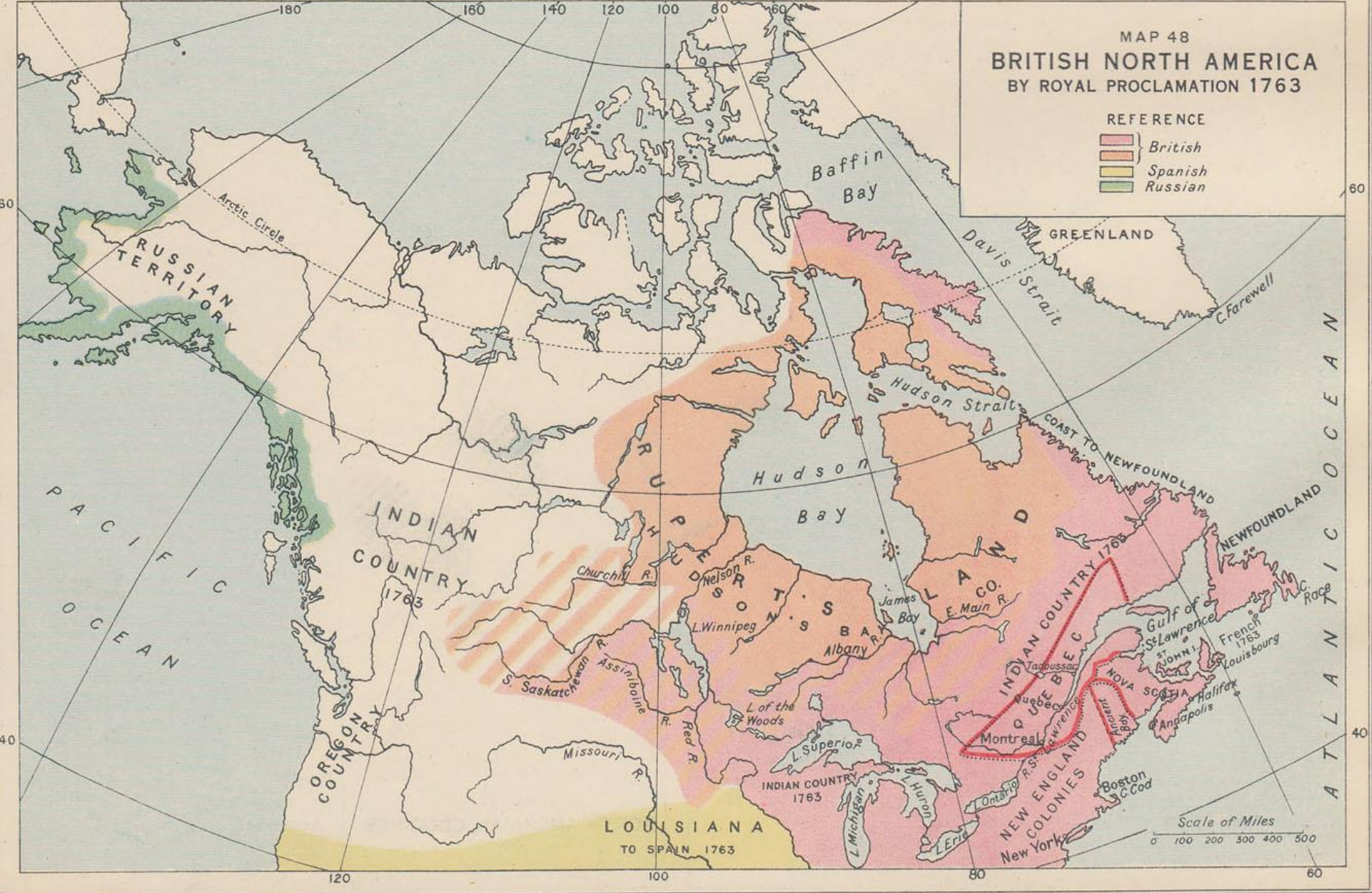
Military Occupation = Satanism

Peace Officers or Criminals?

- All Canada Border Services Agency officers have the words “Peace Officer” on their military uniforms, but if there is no breach of the peace, then they are not operating in their official capacity, but they are operating completely in their private capacity as revenue officers
- 99% of what the Canada Border PIGs do has nothing to do with keeping the peace
- If there is a breach of the peace, 99.99% of the time, it is the Canada Border PIGs that are doing it!

Unlawful Arrest = Assault

- **“Any restraint, however slight, upon another’s liberty to come and go as one pleases, constitutes an “arrest.” Swetnam v. W.F. Woolworth Co., 318 P.2d 364, 366, 83 Ariz. 189.**

Unlawful Arrest = Assault

❖ **“The stopping of an automobile by a highway patrol officer for inspection of a driver’s license, or for any other purpose where it is accomplished by the authority of the officers, is an “arrest.” Robinson v. State, 198 S.W.2d 633, 635, 184 Tenn. 277**

Unlawful Arrest = Assault

- **“An illegal arrest is an assault and battery. The person so attempted to be restrained of his liberty has the same right to use force in defending himself as he would in repelling any other assault and battery.”** State v. Robinson, 145 ME. 77, 72 ATL. 260
- **“Each person has the right to resist an unlawful arrest. In such a case, the person attempting the arrest stands in the position of a wrongdoer and may be resisted by the use of force, as in self-defense.”** State v. Mobley, 240 N.C. 476, 83 S.E. 2d

Unlawful Arrest = Assault

- **“A breach of the peace takes place when either an assault is committed on an individual ...”** R.F.V. Heuston, Salmond on the Law of Torts 131 (17th ed. 1977).” Black’s Law Dictionary, 8th Edition, page 565.

Due Process of Law

❖ **“...the reason for the initial detention, speeding & running a red light are not a breach of the peace.”** Perkins v Texas, 812 S.W. 2d 326

Breach of the Peace

- ❖ Unless there is a breach of the peace, or a common law felony (breach of the peace) committed in front of a peace officer, or they have a lawful warrant, they have nothing to say to you
- ❖ The Canada Border PIGs breach the peace as a routine method of doing business hundreds or thousands of times every day
- ❖ Since Everything west of Quebec is under a military occupation, the Canada Border PIGs engage in war Crimes every day

United Nations Judicial Whores in Canada

- Judicial whores like Rooke, Langsten, Whittman, LeGrandeure, and the Mormon satanist Tilleman, numerous others intend to the Canada Border PIGs assault as many people as possible because it promotes their military dictatorship, and bring in lots of business for their kangaroo courts

Military Occupation = Satanism

- **“Territory is considered occupied when it is actually placed under the authority of the hostile army.**
- **The occupation extends only to the territory where such authority has been established and can be exercised.”** Law and Customs of War on Land (Hague IV), Article 42

Military Occupation = Satanism

- **“In addition to the provisions which shall be implemented in peacetime, the present Convention shall apply to all cases of declared war or of any other armed conflict which may arise between two or more of the High Contracting Parties, even if the state of war is not recognized by one of them.**
- **The Convention shall also apply to all cases of partial or total occupation of the territory of a High Contracting Party, even if the said occupation meets with no armed resistance.**
- **Although one of the Powers in conflict may not be a party to the present Convention, the Powers who are parties thereto shall remain bound by it in their mutual relations. They shall furthermore be bound by the Convention in relation to the said Power, if the latter accepts and applies the provisions thereof.”** Article 2, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]

Military Occupation = Satanism

- **“A place, district, or country occupied by an enemy stands, in consequence of the occupation, under the Martial Law of the invading or occupying army, whether any proclamation declaring Martial Law, or any public warning to the inhabitants, has been issued or not. Martial Law is the immediate and direct effect and consequence of occupation or conquest. The presence of a hostile army proclaims its Martial Law.”** Article 1, Lieber Code [emphasis added]

Military Occupation = Satanism

- **“Martial Law does not cease during the hostile occupation, except by special proclamation, ordered by the commander in chief; or by special mention in the treaty of peace concluding the war, when the occupation of a place or territory continues beyond the conclusion of peace as one of the conditions of the same.” Article 2, Lieber Code [emphasis added]**

Military Occupation = Satanism

- **“NOTE: Under the Law-Martial, only the criminal jurisdiction of a *Military Court* is the recognized law. But as Article Three says, "*the civil courts can continue wholly or in part as long as the civil jurisdiction does not violate the Military orders laid down by the Commander in Chief or one of his Commanders.*" By this means; a military venue, jurisdiction, and authority are imposed upon the occupied populace under disguise of the ordinary civil courts and officers of the occupied district or region, because the so-called civil authorities in an occupied district, or region, only act at the pleasure of a military authority.**
- **It should also be noted here that the several State Legislatures, County Boards of Commissioners, and City Councils, are constantly legislating to please the edicts of the federal government (*the occupying force*) and that their legislation, in this sense, is not an exercise of State sovereignty, but instead, a compliance with edicts of the military force which occupies the several States and consequently are edicts of *Martial Law Rule.*” Dyett v Turner 439 P2d 266 @ 269, 20 U2d 403 [1968] The Non-Ratification of the Fourteenth Amendment by Judge A.H. Ellett, Utah Supreme Court [emphasis added]**

Military Occupation = Satanism

- Why do you think that the Supreme Court of Canada has said that the government has to settle the First Nations Land Claims?

Military Occupation = Satanism

- Evidence that there is a Military occupation
 - Military script circulated for money (Bank of Canada Notes)
 - Police use rank structure of captain, lieutenant, sergeant
 - Police refer to us as “civilians”
 - Courts “presume” everything
 - “curfew” is strictly under a martial law jurisdiction
 - The State Regional Areas under Metro-Government provide the Military Venue for the Peace Officers to enforce Martial Law Jurisdiction (Toronto Metro Police, etc.)
 - BAR members (United Nations – foreign agents) are officers of the court

De facto Law = Military Occupation

- **“Obedience to de facto law – No person shall be convicted of an offense in respect of an act or omission in obedience to the laws for the time being made and enforced by persons in de facto possession of the sovereign power in and over the place where the act or omission occurs.”**, Section 15 of the Criminal Code of Canada
- All of their statutes are de facto when they are under a military occupation

Color of Law = Admiralty = Law of the Sea = Roman Cult

"Canada" , for greater certainty, includes the internal waters of Canada and the territorial sea of Canada;

"person" , or any word or expression descriptive of a person, includes a corporation; Section 35(1) Interpretation Act of Canada

First they assault you with

The ONLY way they can impose the law of the sea on you is by a contract

Color of Law = Municipal Law = Roman Cult

“every one”, “person” and “owner”, and similar expressions, include Her Majesty and an organization;

Section 2 Criminal Code of Canada

“person” includes a corporation and the heirs, executors, administrators or other legal representatives of a person;

Section 28(1)(nn) Alberta Interpretation Act

Color of Law = Municipal Law = Roman Cult

““driver” means a person who is driving or in actual physical control of a vehicle...”

Maxim of Law

“EJUSDEM GENERIS [Latin “of the same kind or class”] A canon of construction that when a general word or phrase follows a list of specifics, the general word or phrase will be interpreted to include only items of the same type as those listed. • For example, in the phrase horses, cattle, sheep, pigs, goats, or any other farm animal, the general language “or any other farm animal” — despite its seeming breadth — would probably be held to include only four-legged, hooved mammals typically found on farms, and thus would exclude chickens. — Cf. EXPRESSIO UNIUS EST EXCLUSIO ALTERIUS; NOSCITUR A SOCIIS; RULE OF RANK.” Black’s Law Dictionary 8th Edition page 1568 [emphasis added]

Include

- **“INCLUDE. (Lat. *inclaudere*, to shut in, keep within). To confine within, hold as in an inclosure, take in, attain, shut up, contain, inclose, comprise, comprehend, embrace, involve. Miller v. Johnston, 173 N.C. 62, 91 S.E. 593. Prairie Oil and Gas Co. v. Motter, D.C.Kan., 1 F.Supp. 464, 468; Decorated Metal Mfg. Co. v. U. S., 12 Ct.Cust.App. 140; In re Sheppard's Estate, 179 N.Y.S. 409, 412, 189 App.Div. 370; Rose v. State, 184 S.W. 60, 61, 122 Ark. 509; United States ex rel. Lyons v. Good Faith = No Jurisdiction = Kangaroo Court

- **“Where a person is required or authorized by law to execute a process or to carry out a sentence, that person or any person who assists him is, if that person acts in good faith, justified in executing the process or in carrying out the sentence notwithstanding that the process or sentence is defective or that it was issued or imposed without jurisdiction or in excess of jurisdiction.”** Criminal Code of Canada § 25(2)
- They hire low intelligence thugs, give them a gun, and tell them to go out and assault people

Military Occupation

- **“The present Convention shall apply from the outset of any conflict or occupation mentioned in Article 2.**
- **In the territory of Parties to the conflict, the application of the present Convention shall cease on the general close of military operations.**
- **In the case of occupied territory, the application of the present Convention shall cease one year after the general close of military operations; however, the Occupying Power shall be bound, for the duration of the occupation, to the extent that such Power exercises the functions of government in such territory, by the provisions of the following Articles of the present Convention: 1 to 12, 27, 29 to 34, 47, 49, 51, 52, 53, 59, 61 to 77, 143.”** Article 6, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]

Military Occupation

- **“Protected persons are entitled, in all circumstances, to respect for their persons, their honour, their family rights, their religious convictions and practices, and their manners and customs.**
- **They shall at all times be humanely treated, and shall be protected especially against all acts of violence or threats thereof and against insults and public curiosity.**
- **Women shall be especially protected against any attack on their honour, in particular against rape, enforced prostitution, or any form of indecent assault.”** Article 27, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]

Military Occupation

- **“Without prejudice to the provisions relating to their state of health, age and sex, all protected persons shall be treated with the same consideration by the Party to the conflict in whose power they are, without any adverse distinction based, in particular, on race, religion or political opinion.**
- **However, the Parties to the conflict may take such measures of control and security in regard to protected persons as may be necessary as a result of the war.”** Article 27, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]

Military Occupation

- They may NOT assault you with the Roman Cult's cestui que trust in order to justify their assaults, kidnappings, etc.

Military Occupation

- **“No protected person may be punished for an offence he or she has not personally committed. Collective penalties and likewise all measures of intimidation or of terrorism are prohibited.**
- **Pillage is prohibited.**
- **Reprisals against protected persons and their property are prohibited.”** Article 33, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]
- When they label you a “Freeman on the Land” and then steal your private conveyance, that is pillage and a reprisal

Military Occupation

- **“The Occupying Power may not compel protected persons to serve in its armed or auxiliary forces. No pressure or propaganda which aims at securing voluntary enlistment is permitted.....”** Article 51, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]
- This is why they cannot do conscription – See the D.I.Y. How NOT to Volunteer for Selective Service and the Draft video

Military Occupation

- **“No contract, agreement or regulation shall impair the right of any worker, whether voluntary or not and wherever he may be, to apply to the representatives of the Protecting Power in order to request the said Power’s intervention.**
- **All measures aiming at creating unemployment or at restricting the opportunities offered to workers in an occupied territory, in order to induce them to work for the Occupying Power, are prohibited.”** Article 52, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]

Military Occupation

- They may NOT compel you to get or use a Social Insurance Number/Social Security Number in order to work, or get compensation for labor
- A Social Insurance Number/Social Security Number is for government employees
- They may NOT compel you to work for the government

Military Occupation

- **“In case of a breach of the penal provisions promulgated by it by virtue of the second paragraph of Article 64, the Occupying Power may hand over the accused to its properly constituted, non-political military courts, on condition that the said courts sit in the occupied country. Courts of appeal shall preferably sit in the occupied country.”** Article 66, Geneva Convention Relative to the Protection of Civilians in Time of War of 1949 [emphasis added]

United Nations = Roman Law = Roman Cult

- **“The States Parties to the present Covenant, including those having responsibility for the administration of Non-Self-Governing and Trust Territories, shall promote the realization of the right of self-determination, and shall respect that right, in conformity with the provisions of the Charter of the United Nations.”** International Covenant on Civil and Political Rights, Article 1, Clause 3 [emphasis added]

United Nations = Roman Law = Roman Cult

- “All persons shall be equal before the courts and tribunals. In the determination of any criminal charge against him, or of his rights and obligations in a suit at law, everyone shall be entitled to a fair and public hearing by a competent, independent and impartial tribunal established by law.” International Covenant on Civil and Political Rights, Article 14, Clause 1

War Crimes

- ***“crime against humanity* means murder, extermination, enslavement, deportation, imprisonment, torture, sexual violence, persecution or any other inhumane act or omission that is committed against any civilian population or any identifiable group and that, at the time and in the place of its commission, constitutes a crime against humanity ...**
- ***genocide* means ...**
- ***war crime* means an act or omission committed during an armed conflict that, at the time and in the place of its commission, constitutes a war crime ...” Crimes Against Humanity and War Crimes Act of Canada, § 4(3)**

War Crimes

- **(1) Every person is guilty of an indictable offence who commits**
- **(a) genocide; (b) a crime against humanity; or (c) a war crime.**
- **Conspiracy, attempt, etc.**
- **(1.1) Every person who conspires or attempts to commit, is an accessory after the fact in relation to, or counsels in relation to, an offence referred to in subsection (1) is guilty of an indictable offence.**
- **Punishment**
- **(2) Every person who commits an offence under subsection (1) or (1.1)**
- **(a) shall be sentenced to imprisonment for life, if an intentional killing forms the basis of the offence; and**
- **(b) is liable to imprisonment for life, in any other case.” Crimes Against Humanity and War Crimes Act of Canada, § 4(1), (2)**

War Crimes

- **(1) The definitions in this subsection apply in this Act.**
- ***conventional international law* means any convention, treaty or other international agreement**
- **(a) that is in force and to which Canada is a party; or**
- **(b) that is in force and the provisions of which Canada has agreed to accept and apply in an armed conflict in which it is involved.**
- ***International Criminal Court* means the International Criminal Court established by the Rome Statute.**”

Canada, § 2 Definitions [emphasis added]

War Crimes

- **“1. The Court shall have jurisdiction in respect of war crimes in particular when committed as part of a plan or policy...**
 - **2. For the purpose of this Statute, ‘war crimes’ means:**
 - **(a) Grave breaches of the Geneva Conventions of 12 August 1949, namely, any of the following acts against persons or property...**
 - **(iv) Extensive destruction and appropriation of property, not justified by military necessity and carried out unlawfully and wantonly;**
 - **(v) Compelling a prisoner of war or other protected person to serve in the forces of a hostile Power;**
 - **(vi) Willfully depriving a prisoner of war or other protected person of the rights of fair and regular trial;**
 - **(vii) Unlawful deportation or transfer or unlawful confinement;”**
- Rome Statute of the International Criminal Court, Article 8(a), War Crimes [emphasis added]

War Crimes

- “Other serious violations..., namely, any of the following acts:
- (i) Intentionally directing attacks against ...individual civilians not taking direct part in hostilities;
- (ii) Intentionally directing attacks against civilian objects, that is, objects which are not military objectives;
- (iv) Intentionally launching an attack in the knowledge that such attack will cause incidental... injury to civilians or damage to civilian objects ... which would be clearly excessive in relation to the concrete and direct overall military advantage anticipated;
- (xiii) Destroying or seizing the enemy's property unless such destruction or seizure be imperatively demanded by the necessities of war;
- (xiv) Declaring abolished, suspended or inadmissible in a court of law the rights and actions of the nationals of the hostile party;
- (xvi) Pillaging a town or place, even when taken by assault;
- (xxi) Committing outrages upon personal dignity, in particular humiliating and degrading treatment;” Rome Statute of the International Criminal Court, Article 8(b), War Crimes [emphasis added]

PIGs in Canada

- Rooke's Pseudo-Commercial Arguments Order is a violation of Article 8(b)(xiv) of the Rome Statute for the International Criminal Court
- (xiv) **Declaring abolished, suspended or inadmissible in a court of law the rights and actions of the nationals of the hostile party;**
- Tilman's order preventing me from filing lawsuits is a violation of Article 8(b)(xiv) of the Rome Statute for the International Criminal Court

PIGs in Canada

- Assault people and steal their property [pillage] because of their political beliefs (freeman on the land)

Penal = Breach of Contract

- “*accused* includes a defendant; (*accuse*)
- *alternative measures* means measures other than judicial proceedings under this Act used to deal with a person who is eighteen years of age or over and alleged to have committed an offence; (*mesures de recharge*)
- *court* means
 - (a) a superior court of criminal jurisdiction,
 - (b) a court of criminal jurisdiction,
 - (c) a justice or provincial court judge acting as a summary conviction court under Part XXVII, or
 - (d) a court that hears an appeal; (*tribunal*)
- *fine* includes a pecuniary penalty or other sum of money, but does not include restitution. (*amende*)” Criminal Code of Canada § 716 Sentencing Definitions [emphasis added]

Penal = Breach of Contract

- “In this section, penalty means the aggregate of
- (a) the fine, and
- (b) the costs and charges of committing and conveying the defaulter to prison, calculated in accordance with regulations made under subsection 734(7).
- Reduction of imprisonment on part payment
- (2) The term of imprisonment in default of payment of a fine shall, on payment of a part of the penalty, whether the payment was made before or after the execution of a warrant of committal, be reduced by the number of days” Criminal Code of Canada 734.8

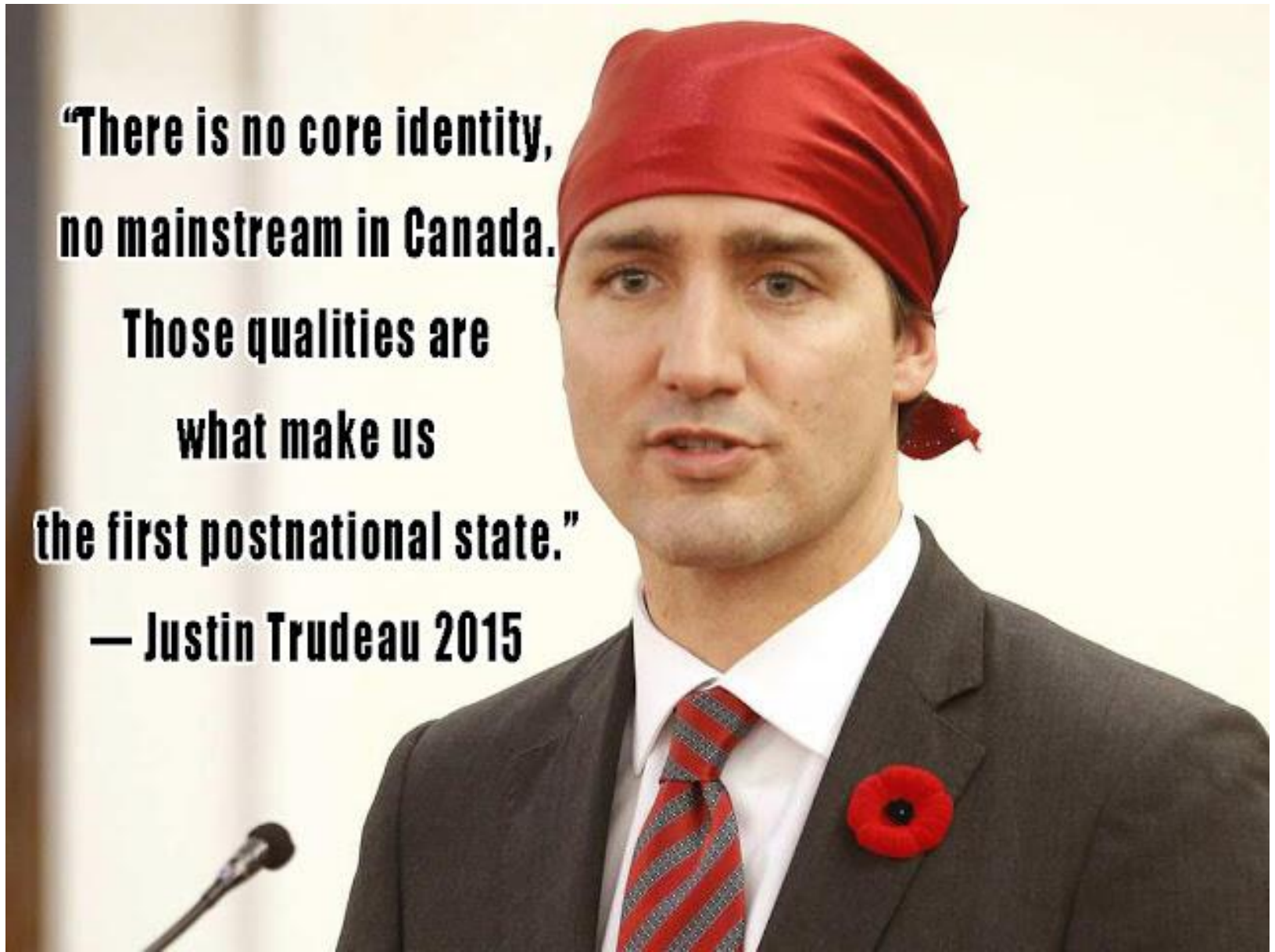

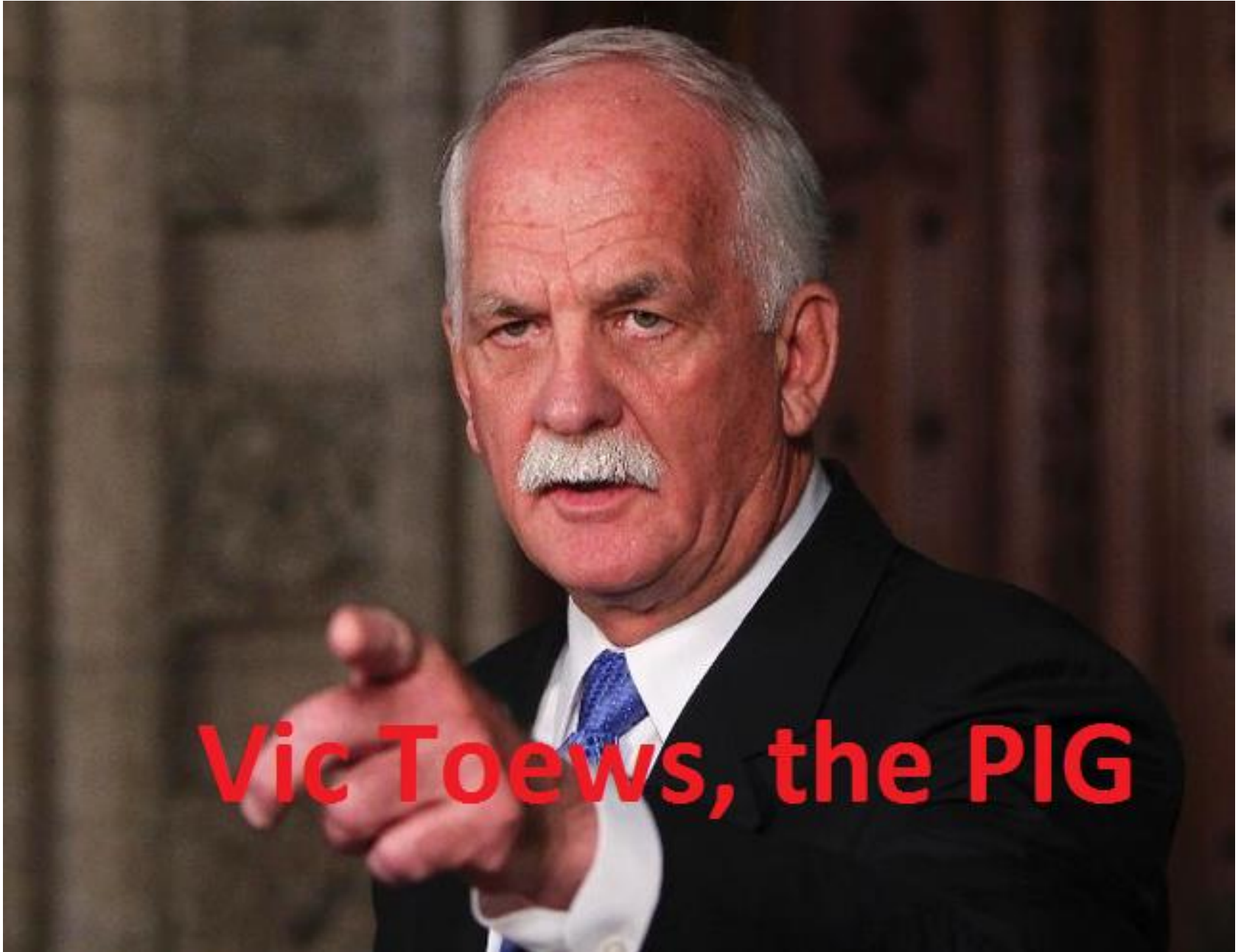

Yesterday defendants Pope Francis Bergoglio, Catholic Jesuit Superior General Adolfo Pachon and Archbishop of Canterbury Justin Welby were found guilty of rape, torture, murder and trafficking of children. Five judges of the International Common Law Court of Justice in Brussels determined that the crimes occurred as recently as 2010. Since last March over 48 eyewitnesses have come forward to testify before this ICLCJ Court about the defendants' activities as members of the Ninth Circle Satanic Child Sacrifice Cult.

The Ninth Circle Satanic Cult was said to do child sacrifices at Roman Catholic cathedrals in Montreal, New York, Rome, Scotland, London, Carnarvon Castle in Wales, an undisclosed French Chateau in Holland and at Canadian Catholic and Anglican Indian residential schools in Kamloops, British Columbia and Brantford, Ontario Canada. The Ninth Circle Satanic Child Sacrifice Cult was believed to use privately owned forest groves in the US, Canada, France and Holland for their "Human Hunting Parties" for global elites including members of European royal

families. Teens were said to be obtained by the mafia, then stripped naked, raped, hunted down and killed. The Chief Prosecutor stated. "The Catholic Church is the world's largest corporation and appears to be in collusion with the mafia, governments, police and courts worldwide."

Two adolescent women told the ICLCJ Court that Pope Francis raped them while participating in child sacrifices. Eight other eyewitnesses confirmed their allegations of being witness to rape and child sacrifices. The Ninth Circle Satanic Cult were said to take place during the Springs of 2009 and 2010 in rural Holland and Belgium.

Pope Francis was also found to be a perpetrator in satanic child sacrifice rites while acting as an Argentine priest and Bishop according to a sealed document obtained from the Vatican archives. A second record dated Dec. 25 1967 called the *Magisterial Privilege* was said to show that every new Pope was required to participate in Ninth Circle Satanic Cult ritual sacrifices of newborn children, including drinking their blood. The documents were presented to the ICLCJ Court by a prominent Vatican official and a former Vatican Curia employee.

Last month an investigator for the Irish Garda Police Force testified before the five judges and 27 jury members that marks on the bones of nearly 796 children found in an Irish Roman Catholic Nun septic tank indicated they had been ritually killed. The witness testified that forensic experts had confirmed the decapitation and dismemberment of the babies in the mass grave resembled the usual signs of ritualistic murder or child sacrifice.

A [BBC documentary](#) exposed a fifty-year scandal of child trafficking by the Catholic church in Spain. Over 300,000 babies were stolen from their parents up to the 1990s. Mothers were told their babies died and were buried in mass graves. The Catholic Church was said to have made \$20 billion dollars on the adoptions.

Another witness testified that they were present during Pope Francis' meetings with the military Junta during Argentine's 1970's Dirty War. According to the witness, Pope Francis helped traffic 30,000 children of missing political prisoners into an international child exploitation ring run by an office at the Vatican.

An [ABC News special](#) hinted that the devil resided at the Vatican. "Documents from Vatican secret archives presented to court clearly indicate that for centuries the Jesuits had a premeditated plan to ritually murder kidnapped newborn babies and then consume their blood," the ICLCJ Court Chief Prosecutor told the five international judges and 27 jury members. "The plan was born of a twisted notion to derive spiritual power from the lifeblood of the innocent, thereby assuring political stability of the Papacy in Rome. These acts are not only genocidal but systemic and institutionalized in nature. Since at least 1773, they appear to have been performed by the Roman Catholic Church, Jesuits and every Pope."

An ongoing and permanent inquiry was organized to investigate and prosecute others involved in possible crimes uncovered at the ICLCJ Court. On September 1 2014 an inquiry was scheduled to begin entitled the Permanent Commission into Child Trafficking and Ritual Sacrifice. Further litigation was expected to follow.

The 48 eyewitnesses identified their perpetrators as Catholic Popes Francis Bergoglio, John Paul II and Joseph Ratzinger; Anglican, United Church of Canada and Catholic Church officials including Cardinals and Catholic Jesuit Superior General Adolfo Pachon; the UK's Queen Elizabeth and Prince Phillip, Anglican Archbishop of Canterbury Justin Welby and High Court Justice Judge Fulford; in the Netherlands: Dutch and Belgian cardinals and royals including Dutch Crown Prince Alfrink Bernhard, King Hendrick, consort to Queen Wilhelmina of Holland, Queen Beatrix, her father and vice-Roy, Prince Johan Friso and his wife Mabel Wisse Smit, former ministers, the top man of the Dutch army force and the under secretary of the Raad van State; officials of the Canadian, Australian, UK and US military and governments including the [USA's CIA](#), plus prominent government ministers, judges, politicians and businessmen of the US, Belgium, Holland, Canada, Australia, France, Ireland and the UK.

Inaugural Canadian Conference in Banff, Alberta

The inaugural Canadian Conference of the J. Reuben Clark Law Society was held October 28-29, 2011 at the historic Banff Springs Hotel in Banff, Alberta.
