Satanic Courts

- **“My opinion is and long has been that the mayor and aldermen of a city corporation, or the president and directors of a bank, or the president and directors of a railroad company and of other similar corporations, are the true parties that sue and are sued as trustees and representatives of the constantly changing stockholders.... A corporation, therefore, being not a natural person, but a mere creature of the mind, invisible and intangible, cannot be a citizen of a state, or of the United States, and cannot fall within the terms or the power of the above mentioned article, and can therefore neither plead nor be impleaded in the courts of the United States.” Rundle v Delaware & Raritan Canal Company 55 U.S. 80 (1852) [emphasis added]**

Satanic Courts

- **“When acting to enforce a statute and its subsequent amendments to the present date, the judge of the municipal court is acting as an administrative officer and not in a judicial capacity; courts administering or enforcing statutes do not act judicially, but merely ministerially....but merely act as an extension as an agent for the involved agency -- but only in a “ministerial” and not a “discretionary capacity...”** Thompson v. Smith, 154 S.E. 579, 583; Keller v. P.E., 261 US 428; F.R.C. v. G.E., 281, U.S. 464 [emphasis added]

Satanic Courts

- **"It is the accepted rule, not only in state courts, but, of the federal courts as well, that when a judge is enforcing administrative law they are described as mere 'extensions of the administrative agency for superior reviewing purposes' as a ministerial clerk for an agency..." 30 Cal 596; 167 Cal 762**

Satanic Courts

- **“Kangaroo court. Term descriptive of a sham legal proceeding in which a person's rights are totally disregarded and in which the result is a foregone conclusion because of the bias of the court or other tribunal.”** Black’s Law Dictionary, 6th Edition, page 868,
- **“Ministerial officers are incompetent to receive grants of judicial power from the legislature, their acts in attempting to exercise such powers are necessarily nullities”** Burns v. Sup., Ct., SF, 140 Cal. 1

All Court Cases are Satanic

- **"It is impossible to prove jurisdiction exists absent a substantial nexus with the state, such as voluntary subscription to license. All jurisdictional facts supporting claim that supposed jurisdiction exists must appear on the record of the court."** Pipe Line v Marathon. 102 S. Ct. 3858 quoting Crowell v Benson 883 US 22

All Court Cases are Satanic

- ❖ **“The judgment of conviction pronounced by court without jurisdiction is void, and one imprisoned thereunder may obtain release by habeas corpus.”** Johnson v. Lewis, 144 U.S. 653.
- ❖ **“Once jurisdiction is challenged, it must be proven.”** Hagens v. Lavine, 415 U.S. 533
- ❖ **“No sanction can be imposed absent proof of jurisdiction.”** Standard v. Olsen, 74 S.Ct. 768

- **“laches (lach-iz). [Law French “remissness; slackness”] 1. Unreasonable delay in pursuing a right or claim — almost always an equitable one — in a way that prejudices the party against whom relief is sought. — Also termed sleeping on rights.” Black’s Law Dictionary 8th Edition, page 2782 [emphasis added]**
- **French Law is civil law (Roman Law)**

- Filing fees are in bank notes – nothing is actually paid for
- **“Sec. 15. As used in this Act the term “United States” means the Government of the United States...the term “currency of the United States” means currency which is legal tender in the United States, and includes United States notes,...Federal Reserve Notes...”**
- **“Sec. 16. The right to alter, amend or repeal this Act is hereby expressly reserved...” “Sec. 17. All Acts and parts of Acts inconsistent with any of the provisions of this Act are hereby repealed.” Gold Reserve Act of 1934, 48 Stat. 337,**

Everything is in equity

- The court rules force the equity
 - If you do not pay the filing fee, they demand an impecuniosity form to justify the equity because you are a “pauper”
 - **“Pauper – One so poor he must be supported at the public expense”** Bouvier’s Law Dictionary 1856 Edition,

Common Law Demands Honesty

- **“At common law only gold and silver were a legal tender. (2 Inst. 577.)”**
McClarín v. Nesbit, 2 Nott & McC. (11 S.C.L.) 519 (1820),
- The whole monetary and financial system is satanic – full of fraud and deception

They Intend to Deny due Process

- **"We therefore decline to overrule the opinion of Chief Justice Marshall: We hold that the District of Columbia is not a state within Article 3 of the Constitution. In other words cases between citizens of the District and those of the states were not included of the catalogue of controversies over which the Congress could give jurisdiction to the federal courts by virtue of Article 3. In other words Congress has exclusive legislative jurisdiction over citizens of Washington District of Columbia and through their plenary power nationally covers those citizens even when in one of the several states as though the district expands for the purpose of regulating its citizens wherever they go throughout the states in union" National Mutual Insurance Company of the District of Columbia v. Tidewater Transfer Company, 337 U.S. 582, 93 L.Ed. 1556 (1948)**

Satanism in America

- Anyone, or any organization that takes advantage of people in any way is satanic
- Anyone or any organization that does not provide full disclosure, or is dishonest in any way is satanic
- All so-called governments are satanic because they pass fictitious laws (color of law) and they use them to get you into a fictitious contract, so they can generate revenue

- ❖ **“"Civil Law," "Roman Law," and "Roman Civil Law" are convertible phrases, meaning the same system of jurisprudence. That rule of action which every particular nation, commonwealth, or city has established peculiarly for itself; more properly called "municipal" law, to distinguish it from the "law of nature," and from international law. See Bowyer, Mod. Civil Law, 19; Sevier v. Riley, 189 Cal. 170, 244 P. 323, 325” Black's Law Dictionary, Rev. 4th Ed.**

Satanic Courts in America

- **“CONFESSION AND AVOIDANCE. In pleading. The admission of the truth of a statement of fact contained in the pleading of the opposite party, coupled with the allegation of a new fact, which obviates or repels its legal effect, and thus avoids it. A pleading framed upon this principle is called a pleading in confession and avoidance, or by way of confession and avoidance. Steph. Plead. 52, 198, 200. 3 Bl. Com. 310.” Burrill A New Law Dictionary, 1871, Volume 1, page 343**

Satanic Courts

- Superior speaks:
- “My son, heretofore you have been taught to act the dissembler: among Roman Catholics to be a Roman Catholic, and to be a spy even among your own brethren; to believe no man, to trust no man. Among the Reformers, to be a reformer; among the Huguenots, to be a Huguenot; among the Calvinists, to be a Calvinist; among other Protestants, generally to be a Protestant, and obtaining their confidence, to seek even to preach from their pulpits, and to denounce with all the vehemence in your nature our Holy Religion and the Pope; and even to descend so low as to become a Jew among Jews, that you might be enabled to gather together all information for the benefit of your Order as a faithful soldier of the Pope.

Jesuit Oath (preamble continued)

- You have been taught to insidiously plant the seeds of jealousy and hatred between communities, provinces, states that were at peace, and incite them to deeds of blood, involving them in war with each other, and to create revolutions and civil wars in countries that were independent and prosperous, cultivating the arts and the sciences and enjoying the blessings of peace. To take sides with the combatants and to act secretly with your brother Jesuit, who might be engaged on the other side, but openly opposed to that with which you might be connected, only that the Church might be the gainer in the end, in the conditions fixed in the treaties for peace and that the end justifies the means [satanism].

Jesuit Oath (preamble continued)

- ...You have received all your instructions heretofore as a novice, a neophyte, and have served as co-adjurer, confessor and priest, but you have not yet been invested with all that is necessary to command in the Army of Loyola in the service of the Pope. You must serve the proper time as the instrument and executioner as directed by your superiors; for none can command here who has not consecrated his labors with the blood of the heretic; for "without the shedding of blood no man can be saved." Therefore, to fit yourself for your work and make your own salvation sure, you will, in addition to your former oath of obedience to your order and allegiance to the Pope, repeat after me---“

Jesuit Oath

- The Extreme Oath of the Jesuits:
- "1, _ now, in the presence of Almighty God, the Blessed Virgin Mary, the blessed Michael the Archangel, the blessed St. John the Baptist, the holy Apostles St. Peter and St. Paul and all the saints and sacred hosts of heaven, and to you, my ghostly father, the Superior General of the Society of Jesus, founded by St. Ignatius Loyola in the Pontificate of Paul the Third, and continued to the present, do by the womb of the virgin, the matrix of God, and the rod of Jesus Christ, declare and swear, that his holiness the Pope is Christ's Vice-regent and is the true and only head of the Catholic or Universal Church throughout the earth; and that by virtue of the keys of binding and loosing, given to his Holiness by my Savior, Jesus Christ, he hath power to depose heretical kings, princes, states, commonwealths and governments, all being illegal without his sacred confirmation and that they may safely be destroyed.

Jesuit Oath (continued)

- Therefore, to the utmost of my power I shall and will defend this doctrine of his Holiness' right and custom against all usurpers of the heretical or Protestant authority whatever, especially the Lutheran of Germany, Holland, Denmark, Sweden, Norway, and the now pretended authority and churches of England and Scotland, and branches of the same now established in Ireland and on the Continent of America and elsewhere; and all adherents in regard that they be usurped and heretical, opposing the sacred Mother Church of Rome. I do now renounce and disown any allegiance as due to any heretical king, prince or state named Protestants or Liberals, or obedience to any of the laws, magistrates or officers.

Jesuit Oath (continued)

- ...I do further declare, that I will help, assist, and advise all or any of his Holiness' agents in any place wherever I shall be, in Switzerland, Germany, Holland, Denmark, Sweden, Norway, England, Ireland or America, or in any other Kingdom or territory I shall come to, and do my uttermost to extirpate the heretical Protestants or Liberals' doctrines and to destroy all their pretended powers, regal or otherwise.
- ...I do further promise and declare, that I will have no opinion or will of my own, or any mental reservation whatever, even as a corpse or cadaver (perinde ac cadaver), but will unhesitatingly obey each and every command that I may receive from my superiors [order taker] in the Militia of the Pope and of Jesus Christ.

Jesuit Oath (continued)

- ...I furthermore promise and declare that I will, when opportunity present, make and wage relentless war, secretly or openly, against all heretics, Protestants and Liberals, as I am directed to do, to extirpate and exterminate them from the face of the whole earth; and that I will spare neither age, sex or condition; and that I will hang, waste, boil, flay, strangle and bury alive these infamous heretics, rip up the stomachs and wombs of their women and crush their infants' heads against the walls, in order to annihilate forever their execrable race. That when the same cannot be done openly, I will secretly use the poisoned cup, the strangulating cord, the steel of the poniard or the leaden bullet, regardless of the honor, rank, dignity, or authority of the person or persons, whatever may be their condition in life, either public or private, as I at any time may be directed so to do by any agent of the Pope or Superior of the Brotherhood of the Holy Faith, of the Society of Jesus.

Jesuit Oath (continued)

- In confirmation of which, I hereby dedicate my life, my soul and all my corporal powers, and with this dagger which I now receive, I will subscribe my name written in my own blood, in testimony thereof; and should I prove false or weaken in my determination, may my brethren and fellow soldiers of the Militia of the Pope cut off my hands and my feet, and my throat from ear to ear, my belly opened and sulphur burned therein, with all the punishment that can be inflicted upon me on earth and my soul be tortured by demons in an eternal hell forever!

Jesuit Oath (continued)

- **"All of which, I, __, do swear by the Blessed Trinity and blessed Sacraments, which I am now to receive, to perform and on my part to keep inviolable; and do call all the heavenly and glorious host of heaven to witness the blessed Sacrament of the Eucharist, and witness the same further with my name written and with the point of this dagger dipped in my own blood and sealed in the face of this holy covenant."** Taken from the book Subterranean Rome by Charles Didier, translated from the French and published in New York in 1843. Dr. Alberto Rivera escaped from the Jesuit Order in 1967, and he describes his Jesuit oath in exactly the same way as it appears in this book. The Jesuit Oath of Induction is also recorded in the Congressional Record of the U.S.A. (House Bill 1523, Contested election case of Eugene C. Bonniwell, against Thos. S. Butler, Feb. 15, 1913, pp. 3215-3216).

Inaugural Canadian Conference in Banff, Alberta

The inaugural Canadian Conference of the J. Reuben Clark Law Society was held October 28-29, 2011 at the historic Banff Springs Hotel in Banff, Alberta. Approximately 100 lawyers, judges, spouses and other guests attended the two-day event. The Calgary, Edmonton and Lethbridge Chapters hosted the Conference.

In his keynote address at the conference, Elder Lance B. Wickman, General Counsel of The Church of Jesus Christ of Latter-day Saints and an Emeritus General Authority noted, "The Adversary has returned to the Courthouse." Elder Wickman then described some of the legal challenges that the Church faces, including challenges to religious liberty. He urged lawyers to use their technical skills for spiritual purposes.

Other speakers at the Conference included Dr. Stephen ZoBell (Group Manager, Pacific Area – LDS Family Services), The Honourable Justice William A. Tilleman (Court of Queen's Bench of Alberta), The Honourable Judge Timothy G. Hironaka (Provincial Court of Alberta), The Honourable Judge Gregory S. The History of the American Inns of Court

The American Inns of Court concept was the product of a discussion in the late 1970's among the United States' members of the Anglo-American Exchange of Lawyers and Judges, including Chief Justice of the United States Warren E. Burger and Judge [J. Clifford Wallace](#) of the U.S. Court of Appeals for the Ninth Circuit. **Burger subsequently invited Rex E. Lee, then Dean of the J. Reuben Clark School of Law at Brigham Young University and later U.S. Solicitor General, and Dallin Oaks, then president of Brigham Young University and later justice of the Utah Supreme Court, to test the idea.**

At the suggestion of Lee, a pilot program was entrusted to Senior U.S. District Court Judge A. Sherman Christensen, who shaped the idea into a workable concept. The first American Inn of Court was founded February 2, 1980 in the Provo/Salt Lake City area of Utah, and included law students from Brigham Young University.

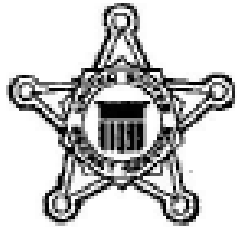

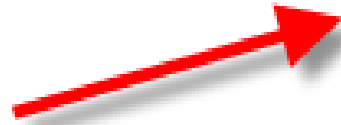
