# Occult = Hidden Knowledge

- “Occult - *adjective* oc·cult \ə- 'kəlt, ä-; 'ä- ,kəlt\
  - **1: not revealed: secret**
  - **2: not easily apprehended or understood: abstruse, mysterious**
  - **3: hidden from view: concealed**
  - **4: of or relating to the occult**
- **Origin of OCCULT - Latin *occultus*, from past participle of *occulere* to cover up, from *ob-* in the way + *-culere* (akin to *celare* to conceal)” Merriam Webster Dictionary online**

# Occult = Hidden Knowledge

- **“The occult (from the Latin word *occultus* "clandestine, hidden, secret") is "knowledge of the hidden".<sup>[1]</sup> In common English usage, *occult* refers to "knowledge of the paranormal", as opposed to "knowledge of the measurable", usually referred to as science. The term is sometimes taken to mean knowledge that "is meant only for certain people" or that "must be kept hidden", but for most practicing occultists it is simply the study of a deeper spiritual reality that extends beyond pure reason and the physical sciences. The terms *esoteric* and *arcane* have very similar meanings, and in most contexts the three terms are interchangeable.”**

# Occult = Hidden Knowledge

- “Definition of *occult* in English:
- Noun (the occult) Supernatural, mystical, or magical beliefs, practices, or phenomena :*a secret society to study alchemy and the occult*
- Adjective - Of, involving, or relating to supernatural, mystical, or magical powers or phenomena: *a follower of occult practices similar to voodoo*
- SYNONYMS
- 1.1 Beyond the range of ordinary knowledge or experience; mysterious: *a weird occult sensation of having experienced the identical situation before*
- 1.2 Communicated only to the initiated; esoteric :*the typically occult language of the time*” Oxford Dictionary Online

# Occult = Hidden Knowledge

- I was always taught that the occult was bad
- Occult is hidden knowledge
- Satanists want you to think occult is bad, because that is the source of their power over you – i.e. ignorance

# Satanism

- ❖ Things that you see every day using the Satanic philosophy of Moral Relativism are;

# Color of Law

- **"It is impossible to prove jurisdiction exists absent a substantial nexus with the state, such as voluntary subscription to license. All jurisdictional facts supporting claim that supposed jurisdiction exists must appear on the record of the court."** Pipe Line v Marathon. 102 S. Ct. 3858 quoting Crowell v Benson 883 US 22

# Color of Law

- **“When acting to enforce a statute and its subsequent amendments to the present date, the judge of the municipal court is acting as an administrative officer and not in a judicial capacity; courts administering or enforcing statutes do not act judicially, but merely ministerially....but merely act as an extension as an agent for the involved agency -- but only in a “ministerial” and not a “discretionary capacity...”** Thompson v. Smith, 154 S.E. 579, 583; Keller v. P.E., 261 US 428; F.R.C. v. G.E., 281, U.S. 464 [emphasis added]

# Color of Law

- **"It is the accepted rule, not only in state courts, but, of the federal courts as well, that when a judge is enforcing administrative law they are described as mere 'extensions of the administrative agency for superior reviewing purposes' as a ministerial clerk for an agency..." 30 Cal 596; 167 Cal 762**



# Color of Law

- **"...judges who become involved in enforcement of mere statutes (civil or criminal in nature and otherwise), act as mere "clerks" of the involved agency..." K.C. Davis, ADMIN. LAW, Ch. 1 (CTP. West's 1965 Ed.)**

# Color of Law

**"Color" means "An appearance, semblance, or simulacrum, as distinguished from that which is real. A prima facia or apparent right. Hence, a deceptive appearance, a plausible, assumed exterior, concealing a lack of reality; a disguise or pretext. See also colorable."**

Black's Law Dictionary, 5th Edition, on page 240.

**"Colour, color. Signifies a probable plea, but which is in fact false..." Tomlin's Law Dictionary 1835, Volume 1**

# Color of Law

**"Colorable" means "That which is in appearance only, and not in reality, what it purports to be, hence counterfeit feigned, having the appearance of truth." Windle v. Flinn, 196 Or. 654, 251 P.2d 136, 146.**

**"Colourable - Presenting an appearance that does not correspond with reality, or an appearance intended to conceal or deceive. Etherington v Wilson (1875), 1 Ch.D. 160"**  
**Barron's Dictionary of Canadian Law, Sixth Edition, page 51**

# Color of Law

**"Color of Law" means "The appearance or semblance, without the substance, of legal right. Misuse of power, possessed by virtue of state law and made possible only because wrongdoer is clothed with authority of state is action taken under 'color of law.'" Atkins v. Lanning. D.C.Okl., 415 F. Supp. 186, 188.**

**"Colour of Law - Mere semblance of a legal right. An action done under colour of law is one done with the apparent authority of law but actually in contravention of law." Barron's**

# Satanic Courts

- Clerks cannot issue Warrants or ORDERS or do anything judicial, and they try, it is a fraud (lie) and a nullity
- **"Ministerial officers are incompetent to receive grants of judicial power from the legislature, their acts in attempting to exercise such powers are necessarily nullities"** Burns v. Sup., Ct., SF, 140 Cal. 1

# Color of Law

- If they have to get your consent (a contract) to obtain jurisdiction, and
- If all judges becomes Clerks working for the prosecutor when enforcing any statute
- If a Clerk masquerading as a Judge cannot do anything judicial
- Then
  - All statutes are color of law
  - All statutes have to be consented to
  - All statutes are satanic (full of fraud and deception)
  - A Code is a compilation take from statutes, which means that code are worth less than a statute

# Color of Law

- If all statutes are satanic color of law, then
  - Those who make the statutes are satanists (Congress – Parliament – Legislatures)
  - Those who elect the satanists are also satanists (voters)
  - Why are we surprised when Mark Passio (former satanist priest) says that 2/3 of Americans are Satanists?

- ❖ **"It is one of the fundamental maxims of the common law that ignorance of the law excuses no one." Daniels v. Dean (1905), 2 C.A. 421, 84 P. 332.**



# Common Law

- Common Law is decisions of courts
  - Common Law of England
  - Common Law of United States (District of Columbia)
- The Common Law that the founding fathers brought to America with the Constitution is the Common Law of England
- The Common Law of England is 800 years of jury trial decisions

# Common Law

❖ **"History is clear that the first ten amendments to the Constitution were adopted to secure certain common law rights of the people, against invasion by the Federal Government." Bell v. Hood, 71 F.Supp., 813, 816 (1947) U.S.D.C. -- So. Dist. CA.**

# Ignorance

- Codes are NOT common law
- Statutes are NOT common law
- That is why they have to make their codes and statutes available – Notice – Common Law
- Caligula, used to write Roman statutes in really small print and put it up at the top of a very tall pole to satisfy the Notice requirement
- Today they write literally millions of them and bury them in a law library with literally millions of court cases inside tens of thousands of books

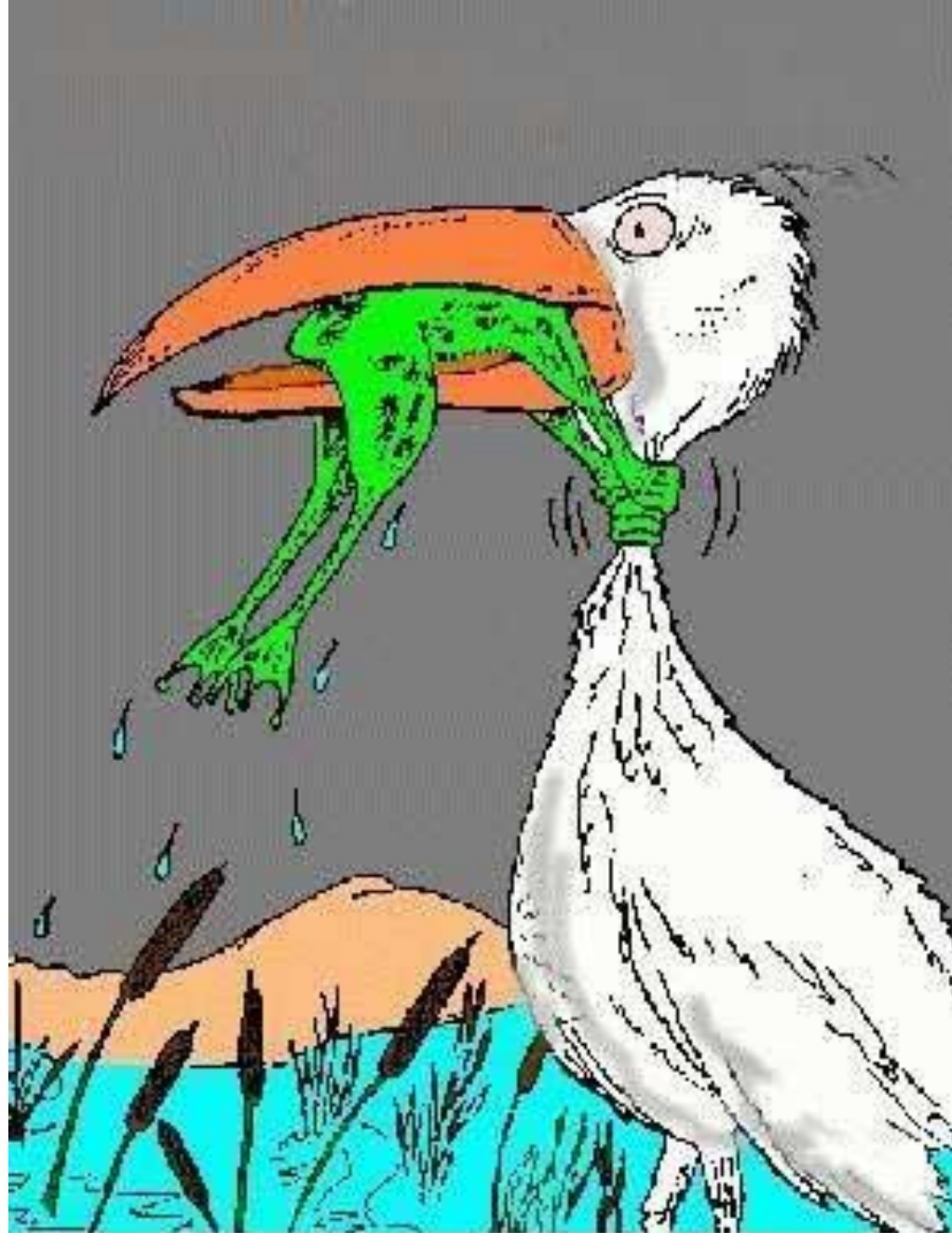
- We discussed
