What can I do?

- **Many people have wanted me to assert their sovereignty for them.**

What can I do?

What can I do?

- If I have to do it for you, then I have to represent you.

What can I do?

- I can prepare your paperwork

What can I do?

What can I do?

- **For my services I charge 3 pieces of pure silver (1 troy ounce each) per hour**
 - **You can pay it with dollars as defined by the Coinage Act of 1792 which has never been repealed or modified**
 - **You can also pay it with pieces of silver that you get from one of the many mints, like the Northeastern mint**

What can I do?
